CITY OF KELOWNA BYLAW NO. 9289

Amendment No. 1 to Kelowna Memorial Park Cemetery Bylaw No. 8807

A bylaw to amend the "Kelowna Memorial Park Cemetery Bylaw No. 8807".

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts that the City of Kelowna Memorial Park Cemetery Bylaw No. 8807 be amended as follows:

- 1. THAT the first paragraph be amended by replacing the words "Section 885 of the *Local Government Act*" with "Section 8 of the *Community Charter*";
- 2. AND THAT **Section 1.2 Interpretation** sub-section 1.2.4 Schedules be amended by:
 - a) Deleting "Schedule B Cemetery Licenses" and replacing it with "Schedule B Right of Interment Fees"; and
 - b) Deleting "Schedule D Surrender or Transfer of License" and replacing it with "Schedule D Surrender or Transfer of Right of Interment";
- 3. AND THAT **Section 1.3 Definitions** be amended as follows:
 - (a) Sub-section 1.3.1 be amended by adding in the following definitions in its appropriate place as follows:
 - i) ""Family Estate" means a walled or semi walled space intended to be used for the interment of human remains and/or cremated remains under a right of interment.";
 - ii) "**Right of Interment**" means a right, in perpetuity, for the interment of human remains or cremated remains, in a lot."; and
 - ""Section G7" of the Cemetery means the grassed area consisting of double depth in-ground lawn crypts and Family Estates as shown on Schedule "G". ";
 - (b) Sub-section 1.3.1 be amended by amending the following definitions in its appropriate place as follows:
 - i) Add the sentence "The purchase of a mausoleum crypt, niche or memorial wall in Section G2 includes a standard name plate and opening and closing." to the end of the definition for "Section G2";
 - ii) Replace the definition for "**Section G3**" with the following:
 - "Section G3" of the Cemetery means the grassed area within the **Promontory Green Interment Garden** consisting of companion (3" x 3") and family cremation plots (3" x 6") as shown on Schedule "G";

- iii) Replace the definition for "**Section G5**" with the following:
 - "Section G5" of the Cemetery means the grassed area consisting of companion (3" x 3") and family cremation (3" x 6") plots as shown on Schedule "G";
- iv) Replace the definition for "Section G6" with the following:
 - "Section G6" of the Cemetery means the grassed area consisting of companion (3" x 3") and family cremation (3" x 6") plots as shown on Schedule "G".
- 4. AND THAT **PART 2 CITY OF KELOWNA CEMETERY BOUNDARIES** be amended by deleting Sub-section 2.2 "Cemetery Plans" and replacing it with the following:
 - "2.2 Cemetery Plans. A copy of the plans of the Cemetery shall be kept available for public inspection at the Cemetery and such places that may be deemed necessary."
- 5. AND THAT PART 3 CEMETERY LICENCE be renamed "PART 3 RIGHT OF INTERMENT" and be amended by:
 - a) After the words "plots which may be vacant and" delete the word "unlicensed" and replace it with "not issued as a **Right of Interment**" in Sub-section 3.2 "<u>Licence for Exclusive Use</u>"; and
 - b) Sub-section 3.5 "Transfer Request" be deleted and replaced with the following:
 - "3.5 <u>Transfer Request</u> The transfer request must be in writing by the holder of a **Right of Interment** as set out in Schedule "D". **Right of Interments** for **plots** must be surrendered, and a transfer fee as set out in Schedule "A" shall be paid to the City. The **Cemetery Manager** shall amend his records accordingly stating the new holder of the **Right of Interment** of the **plot** or **plots**."
- 6. AND THAT **PART 4 FEES AND CHARGES**, sub-section 4.3 <u>Instalment Plan</u> be amended by replacing the word "re-sell" in the second paragraph with "re-issue";
- 7. AND THAT **PART 5 PERMISSION TO INTER, EXHUME AND CREMATE** be amended as follows:
 - (a) Sub-section 5.3 <u>Application for Permit</u> be deleted and replaced with the following:
 - "5.3 Application for Permit All applications for an interment permit must be made at least 24 hours (1 working day), and during the winter months from November 1 to March 15 of each year 48 hours (2 working days); the Pioneer Section requires 48 hours (2 working days) before the scheduled interment, to the Cemetery Manager between the hours of 8:00 a.m. and 4:00 p.m. on all days of the week except Saturday and Sunday, Statutory Holiday, and in cases of emergency, as described in Sections 5.5, 5.6 and 5.7 of this bylaw.";
 - (b) Sub-section 5.5 <u>Interment After Hours</u> be amended by replacing the word "**Director**" with "**Cemetery Manager**";

- AND THAT PART 6 INTERMENT IN THE CEMETERY be amended as follows:
 - (a) Sub-section 6.6 <u>Number of Interments</u> be deleted and replaced with the following:
 - "6.6 Number of Interments In Sections C, D, E1, E2, E3 and G4 and in the upright monument portion of Sections A, B and E4 where the grave top is not covered by hard surfacing, two (2) casket interments plus two (2) cremations will be permitted in each large plot. In Section G1 and G7 Lawn Crypts, only two (2) interments are allowed. An additional use fee will be applied for the third and subsequent burial in a single plot";
 - (b) Sub-section 6.14 No Interment on Weekends or Statutory Holidays be amended by deleting the words "No interments will be scheduled on long weekends that are a result of a statutory holiday or on a statutory holiday";
 - (c) Sub-section 6.15 <u>Grave Digging or Opening</u> be deleted and replaced with the following:
 - "6.15 Grave Digging Opening or Closing. No grave shall be dug, opened or closed by any person other than the Caretaker and his assigned helpers or other person duly authorized by the City. Witnesses to a grave closing must adhere to WCB rules and regulations with the respect of safety and only with permission by the Cemetery Manager.";
- AND THAT PART 9 ADMINISTRATION AND MAINTENANCE be amended as follows:
 - (a) Sub-section 9.3 <u>Grant Licence</u> be deleted and replaced with the following:
 - "9.3 Grant Right of Interment. The Cemetery Manager is hereby authorized on behalf of the City to grant a Right of Interment in the form set out in Schedule "B" in respect of any vacant and not issued Right of Interment plot in the Cemetery, according to the fees and charges specified in Schedule "A" and subject to the provisions of this bylaw.";
- 10. AND THAT **PART 10 ADORNMENT** be amended as follows:
 - (a) Sub-section 10.3 <u>Removal of Offerings</u> be amended by adding the following sentence at the end of the paragraph:
 - "The **Cemetery** cannot be held accountable for any offerings removed by an act of vandalism.";
 - (b) Sub-section 10.7 Enclosures. be deleted and replaced with the following"
 - "10.7 <u>Enclosures</u> No grave or grave space shall be bounded or enclosed by a fence, hedges, railing except those that are allowed in the Pioneer Section or the **Family Estates** of the **Cemetery** that are part of the design feature.";

- (c) Sub-section 10.8 <u>Specifications</u> be amended by adding a new sub- paragraph (d) as follows:
 - "(d) Where an upright memorial is placed in a **Family Estate** only one (1) will be permitted and shall not exceed the width and depth of the foundation provided. Where cremation memorial tablets are placed between the full-size adult plots in accordance with Schedule "F", the first cremation tablet shall be centred and set directly upon the cremation **plot**. Each of the following cremation memorials shall, in turn, be centred directly below each other. All ornamentation such as benches, large vases and other adornments must be made of granite and meet the approval of the **Cemetery Manager**.";
- 11. AND THAT **PART 11 GENERAL REGULATIONS** sub-section 11.11 <u>Excessive</u> <u>Maintenance</u> be amended by deleting the word "will" after the words "raised memorials or other edifices";
- 12. AND THAT **SCHEDULE** "A" be repealed in its entirety and replaced with a new **SCHEDULE** "A" attached to and forming part of this bylaw;
- 13. AND THAT **SCHEDULE** "B" be repealed in its entirety and replaced with a new **SCHEDULE** "B" attached to and forming part of this bylaw;
- 14. AND THAT **SCHEDULE** "C" be amended by deleting "CITY OF KELOWNA" and replacing it with "KELOWNA MEMORIAL PARK CEMETERY";
- 15. AND THAT Schedule "F" be amended as follows:
 - (i) Deleting the word "**Director**" and replacing it with "**Cemetery Manager**" in Paragraph number 4;
 - (ii) Deleting the measurements "18" X 30" Paragraph number 6.(i)(B) and replacing it with the measurements "16 X 28"; and
 - (iii) Paragraph 6(vi) On Cremation Plots is hereby amended by adding the following paragraph;

"The placement of additional memorials for Cremation required on the surface of full sized Adult graves should be 12" X 20" (30.38 cm x 50.8 cm) and placed according to Section 10.8 (c).";

(iv) A new paragraph numbered 6(vii) **Family Estates** is hereby enacted as follows and all other paragraphs should be renumbered in their subsequent order:

(vii) Family Estates

One (1) upright memorial placed upon the provided foundation. Individual cremation memorials will be 12" x 20" made of bronze and mounted on granite base.

All approved ornamentation such as benches, large flower vases must be made of granite and approved by the **Cemetery** Manager."

- 16. AND THAT the layout plan for the City of Kelowna Memorial Park Cemetery Section "G" be repealed in its entirety and replaced with a new layout plan attached to and forming part of this bylaw;
- 17. AND THAT the words "Licence", "Cemetery Licence" or "Cemetery Licences" be replaced with the words "Right of Interment" or "Rights of interment", wherever they appear in the bylaw;
- 18. AND THAT all references "Cemetery and Funeral Service Act" be replaced with "Cremation, Interment And Funeral Services Act", wherever they appear in the bylaw;
- 19. AND THAT all references to the "Local Government Act" be deleted and replaced with "Community Charter";
- 20. This bylaw may be cited as "Bylaw No. 9289 being Amendment No. 1 to Kelowna Memorial Park Cemetery Bylaw No. 8807".
- 21. This bylaw shall come into full force and effect and be binding on all persons on October 1, 2004.

A refund for cancellation of Right of Interment will be a sum equivalent to that paid for such Right of Interment at the time of issuance <u>less</u> the maintenance fee paid at the time of issuance.

- This Right of Interment is for the use of the plot only and all fees and charges relate solely to the 1. plot and do not include any other charges, including without limitation, charges for:
 - grave services, such as opening and closing graves at time or interment or disinterment

A failure by the Applicant to so comply will entitle the City to either correct the failure at the Applicant's cost or, where interment in the plot has not yet occurred, revoke this Right of Interment upon repayment to the Applicant of the plot price less the Cemetery Maintenance Fund.
- Subject to the City's rights to reclaim the plot pursuant to the Cremation, Interment and Funeral 3. Services Act, the plot may be surrendered to the City at any time, the City will pay to the legal owner of such plot the plot price paid pursuant to this agreement less the Cemetery Maintenance Fund.
- 4. The City reserves the right to procure, store, or install goods covered by this agreement, and to be reimbursed immediately for any goods or services that have been prepaid in advance of need. In return, the City guarantees to deliver the goods and services when required without additional charge. Any funds paid by the City for goods and services under this agreement will not be refundable to the Purchaser once the City has started to discharge the obligation to provide these goods and services even if only by the pre-need procurement, storage or installation of these goods.

The foregoing terms and conditions of the Right of Interment are hereby acknowledged and agreed to by the Applicant.
