1. CALL TO ORDER

Mayor Gray called the meeting to order at 1:30 p.m.

2. Councillor Nelson was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.1 Mark Flett, Okanagan Film Commission re: Okanagan Film Industry

Mr. Mark Flett brought Council up to date on efforts by his office to market the Okanagan to the film industry over the past year. He advised the Okanagan Film Commission is funded until November 1999 by Human Resources Canada and are looking at setting up partnerships throughout the area for funding after that date.

8. <u>COUNCILLOR ITEMS</u>

(a) Pawn Shop Bylaw

Councillor Shepherd requested a report from staff regarding the status of the City's Pawn Shop Bylaw.

(b) Design of City-Owned Parkades

Councillor Day advised that he will be asking staff through the Parking Committee to review the design of the two parkades owned by the City to see if they comply with the Crime Prevention Through Environmental Design (CPTED) guidelines and will report back to Council with the results.

(c) <u>Liquor Licensing Review</u>

Councillor Hobson noted that the industries involved with food and liquor service have reported that they achieved a consensus agreement on liquor licensing issues at a recent meeting in the Lower Mainland. The City of Kelowna is already on record requesting an opportunity for municipal review of any recommended changes through the UBCM prior to changes in liquor licensing. However, some of the changes being recommended by the liquor industry representatives would significantly increase the availability of liquor even though the social and community impacts of this expansion have not yet been determined. Some of the proposed changes include expanding the number of licensed establishments, expanding the seating capacity of existing liquor operations, and increasing the hours that licensed establishments are able to sell liquor.

(d) <u>Crown Lands on the South Slopes</u>

Councillor Hobson advised that the Provincial Ministry of Finance and the Ministry of Environment, Lands and Parks are selling off Crown Land to help deal with the provincial deficit. There has been constant debate regarding sale of the deeded Crown lots and there is strong opinion in the community that the Crown lands on the South Slopes should never be considered for sale and should be retained in public ownership. Councillor Hobson referred to a letter to MLA Cindy Hawkins from the British Columbia Assets and Land Corporation regarding one area of Crown Land at the south end of Sallows Road that has been reserved for future housing purposes since 1976. Councillor Hobson advised that the City of Kelowna's planning documents have never indicated the Crown Lands in the South Slopes area as future housing reserve and asked that a letter be sent to once again state that the City of Kelowna wants these lands to be retained for recreational purposes.

Moved by Councillor Hobson/Seconded by Councillor Shepherd

R91/99/02/01 THAT a letter be sent to the Minister of Environment, Lands and Parks, the Minister of Finance, and the B.C. Assets and Land Corporation stating that Kelowna City Council does not deem the area of Crown Land at the end of Sallows Road to be a future housing reserve, and reiterating that the City of Kelowna wants the entire South Slopes area to be retained in public ownership for recreational purposes.

Mayor Gray informed Council that he intends to send copies of the position paper received from the campground and resort operators on the issue of a 2% hotel/motel tax to the Hotel/Motel Association, the Chamber of Commerce and the Mayors of Vernon and Penticton for their review.
