A Regular Meeting of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Monday, June 21, 1999.

1. CALL TO ORDER

Mayor Gray called the meeting to order at 1:30 p.m.

2. Councillor Day was requested to check the minutes of the meeting.

Mayor Gray read a proclamation declaring June 21, 1999 as National Aboriginal Day.

3. PUBLIC IN ATTENDANCE

3.1 Kelowna Youth Employment Initiative Team re: 1999 Initiatives

Marcie Goodall, Erin Bassingthwaighte and Brandon Solms each gave presentations on the various initiatives they will implement this summer to raise awareness of road safety among youth in Kelowna and throughout the Okanagan.

The Director of Parks & Leisure Services entered the Council Chamber at 1:44 p.m.

4. UNFINISHED BUSINESS

4.1 Parks Manager, dated June 9, 1999 re: <u>Dogs in Parks Program</u> (6140-02)

The Parks Manager advised this item was deferred from the June 14, 1999 Council Meeting and that the staff recommendation remains unchanged, as follows:

THAT the portion of Sutherland Park north of the boat launch and Government Campground Park cease to be "dogs off leash" parks and that those same lands be designated as "dog walking parks";

AND THAT the City-owned land west of Dilworth Drive between the CN Tracks and Leckie Place Road, as outlined by Map 1 attached to the Park Manager's report dated June 9, 1999, be designated as a "dog off leash park" on a 1 year trial basis;

AND FURTHER THAT the Parks & Leisure Services Department endeavour to provide an "off leash dog park" in each guadrant of the city for the year 2000.

Mr. Guy King, Okanagan Dog Owners Association (ODOA), argued in support of continued use of Sutherland Park as a dog off-leash park and asked that Council approve the south part of Sutherland Park as a completely fenced off-leash dog park with gates that would only open inward in order to keep the dogs in. Mr. King indicated that the ODOA would be willing to contribute toward some of the costs once their membership grows and their finances become stronger. Meanwhile he recommended that the dog licensing fees be reduced and that the ODOA undertake some fundraising programs to contribute toward fencing, etc. Mr. King also suggested that the complaints about odour are probably from the bins where dog owners are depositing feces and more frequent pick-up would help that. Complaints about owners not leashing their dogs to and from the park can be resolved through proper education and signage.

Miriam & Hans Van Leening addressed Council on behalf of the area residents, advising that the consensus of the neighbourhood was for both Sutherland Bay Park and Government Campground Park to be removed from the dog park list. Their concerns were public health, odour, noise, and increased maintenance costs from wear and tear on the land, none of which would be addressed simply by fencing the dog park. He noted the amount of traffic in the neighbourhood increased substantially as the off-leash park became known. He advised that there have been many complaints in the past, not just a few and suggested that education only works when there is a fine imposed for non-compliance.

Council debated the matter at length and finally agreed to deal with the staff recommendation one paragraph at a time.

Moved by Councillor Leask/Seconded by Councillor Bremner

<u>R530/99/06/21</u> THAT the portion of Sutherland Park north of the boat launch and Government Campground Park cease to be "dogs off leash" parks and those same lands be designated as "dog walking parks".

Councillors Cannan and Shepherd opposed.

There was no mover or seconder for the second paragraph of the staff recommendation to designate a City-owned property west of Dilworth Drive as a dog off-leash park for a one year trial basis.

Council agreed to change the wording in the third and final paragraph of the staff recommendation to read off-leash dog **area** instead of park, since both public and privately owned land will be considered.

Council directed staff to contact the Regional Dog Control and request increased enforcement at Sutherland Bay Park and Government Campground Park.

The Director of Planning & Development Services, the Long Range Planning Manager, and the Planner – Long Range entered the Council Chamber and the Director of Parks & Leisure Services, the Parks Manager, and the Parks Coordinator left at 3:30 p.m.

5. CORRESPONDENCE

5.1 Regional District of Central Okanagan, dated June 17, 1999 re: <u>Growth Management Strategy Bylaw</u> (0482-01)

The Planner–Long Range presented a recap of the Growth Management Strategy process, summarized the public input received at the public meeting in which all of Council participated on June 16th at the Ramada Lodge Hotel, and highlighted the recommendations in the report.

A member of Council noted that the Regional Growth Strategies Act starts out saying a regional district *may* adopt a strategy but after that the words *must* and *will be imposed* are used. He expressed concern that once the Regional Board adopts this bylaw, if the municipalities within the regional district are unable to agree on a successful conclusion a facilitator would be appointed; if the facilitator is unsuccessful, then the province would impose the strategy on the municipalities; and one day we may find ourselves with a government overseeing this region that may not be the right one.

The Planner–Long Range advised that upon adoption of the Growth Management Strategy Bylaw by the Regional Board, municipal governments have a 2-year time period in which to prepare Regional Context Statements for inclusion in their respective OCPs, to demonstrate how the OCPs are consistent with the Strategy Bylaw.

Council agreed to add to the motion a request to expand objective No. 9 to also reference air and water quality in the Regional District.

Moved by Councillor Shepherd/Seconded by Councillor Day

<u>R533/99/06/21</u> THAT the Growth Management Strategy Bylaw Schedule "A", as outlined in the Department of Regional and Community Planning's report of June 17, 1999, be received for the information of Council;

AND FURTHER THAT the Growth Management Strategy Bylaw, as amended, be endorsed by Council.

- The Kelowna Minor Sport Association regular (September 1st April 30th) season ice rate for school days; (6:00 a.m. 3:00 p.m.),school breaks; (6:00 a.m. 8:00 a.m.) and school days and breaks; (10:00 p.m. 12 midnight) be the same as for other City of Kelowna arenas;
- The Kelowna Minor Sport Associations regular (September 1st April 30th) season ice rate for school days; (3:00 p.m. 10:00 p.m.) and school breaks (8:00 a.m. 10:00 p.m.) rate be 75% of the benchmark rate;
- The non-Kelowna based Minor Sports Association ice rate be 150% of the benchmark rate;
- The School District No. 23 rate be the same as for other Kelowna arenas;
- The Kelowna Minor Sport Association dry floor rate be 50% of the benchmark rate;
- All rates being phased in incrementally on September 1st, over each of the next 4 years (1999, 2000, 2001, 2002);

AND THAT community event rental rates be 125% of the other City of Kelowna arenas plus additional set up costs as charged by Skyreach Place;

AND THAT City staff negotiates with Skyreach Place for a Public Skating Partnership which will include public admission fees;

AND FURTHER THAT the Skyreach Place Rates, Fees and Charges for **community use time** be reviewed annually to consider the impact of operating cost requirements and, if necessary, recommend rate changes.

9. <u>COUNCILLOR ITEMS</u>

(a) <u>Culos Property Between Uplands Court/Viewcrest Court</u>

Councillor Leask referred to a letter members of Council have received regarding the construction of a paved road by a developer to gain access to lots he is developing below properties in the Uplands/Viewcrest Court area of the Mission. The road was built without approval from the City and is an intrusion on the lots above. The City Manager advised that building permits would be withheld if the subdivision has not been developed in accordance with the site grading plan. The developer has been so informed.

(b) Status Report - Proposed Military Museum

Councillor Leask asked for a status report on the future development of a military museum in Kelowna. Mayor Gray advised that staff have already been asked to provide a report on how the project is progressing.

(c) <u>City Boulevards</u>

Councillor Shepherd commented that many of the grassed boulevards on Pandosy Street between the town centre and the hospital are unsightly. Some residents may have discontinued watering the boulevards because of the implementation of water meters. With the boulevards on the other side of the sidewalk those residents still willing to water have to deal with skateboarders running over their hoses or throwing the hoses back into their yards. Something different needs to be considered. Mayor Gray advised that the Parks Manager is looking into that and will be reporting back with a recommendation that will likely be for pavers to be installed.

(d) Medians – Highway 97

Councillor Shepherd enquired when trees will be planted in the medians recently installed along Highway 97 by the Ministry of Transportation and Highways. The City Manager advised that water has been provided to the medians but he could not say for sure whether anything further would be done this year; the medians at McCurdy Road may be done earlier and that will be investigated.

(e) Rutland Business Association

Mayor Gray reported that the Rutland Business Association held their first annual meeting last Thursday. The meeting was well attended and it was encouraging to see such enthusiasm in a group so recently formed.
