1. CALL TO ORDER

Acting-Mayor Blanleil called the meeting to order at 1:30 p.m.

2. Councillor Cannan was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.1 Bill Mah, Canadian National Institute for the Blind re: <u>National Braille</u> Awareness Day

8. COUNCILLOR ITEMS

(a) Signage at Intersections

Councillor Cannan expressed concern that there are intersections in Kelowna where turning instructions are only painted on the road making it so that visitors or residents new to the city do not know which lane to be in when the roads are covered with snow. He asked that staff look into using overhead signage at all intersections.

(b) Parking at Skyreach Place

Councillor Hobson referred to an article in this morning's newspaper about parking problems at the Homeshow event held at Skyreach Place on the weekend. He suggested that the Parking Committee discuss the concerns with Imperial Parking and the owners of Skyreach.

Councillor Day agreed to raise the matter with the Parking Committee but reminded Council that it is a private parking lot and therefore a matter between Skyreach and their contractor.

(c) Cedar Creek Park

Councillor Shepherd advised that she has received phone calls about work being carried out at Cedar Creek Park. Apparently the soil that cannot be removed from the site without a permit is now being distributed over the site. She expressed concern that this is contrary to what the area residents were told would happen and asked for a report from staff on what is being done.

(d) Parking Meters

Councillor Nelson noted that indicating the days and times that the parking meters have to be plugged *inside* the parking meters works during daylight hours but not after dark. He suggested that the information needs to be visible on the meter where it can be easily read at night as well.
