1. CALL TO ORDER

Mayor Gray called the meeting to order at 9:10 a.m.

2. Councillor Cannan was requested to check the minutes of the meeting.

3. REPORTS

3.1 Mayor Gray re: B.C. Seniors Games - Pins

Council:

- Agreed to approve this request in advance of hearing back from the Sports Tourism Committee on the results of their questionnaire regarding the issue of pins.
- After Sports Tourism reports back, a policy be developed for dealing with requests for City pins.

3.2 Councillor Shepherd re: Community Heritage Commission - Speed Limit in Conservation Areas

Councillor Shepherd:

- The Community Heritage Commission is encouraging implementation of traffic calming measures in the Abbott Street and Marshall Street Heritage Conservation Areas including reducing the speed limit from the unposted speed limit of 50 km/hr. to a posted 30 km/hr. limit as a method of protecting mature hedges that are encroaching on sight lines at some of the intersections in these areas.

Council:

- Did not support a speed limit that would be different from other residential areas.

Staff:

- Are continuing to work with the Ministry of Transportation and Highways toward no left turns from Abbott Street onto the bridge.

Councillor Shepherd:

- The brick building was in the 1983 inventory of heritage properties but has not yet been reviewed for inclusion in the City of Kelowna Heritage Register.
- Friends of KSS would like to see the building preserved and enhanced and are considering selling bricks to raise funds. The bricks would stay in place and the funds would be used to revitalize the building.

3.4 Councillor Shepherd re: Tax Relief Request from Servants Anonymous Society

Council:

- Agreed to defer considering this request until the owners of the property apply for an exemption for 2001 taxes.
