- Market research conducted by Telus has shown that over 75% of the public would support an expansion of the calling area if it comes forward.
- Overall, the expansion proposal would be financially neutral to Telus.
- Anticipate the expanded local calling area could be in place by the second quarter of 2001.

5.3 Planning & Development Services Department, dated August 24, 2000 re: <u>Housing Opportunities Reserve Fund Bylaw</u> (5040-20)

Staff:

- Establishment of a Housing Reserve Fund Bylaw was a primary recommendation from the Housing Study.
- The proposed bylaw addresses only low income or special needs housing.
- The intent would be to acquire lands for the purpose of housing to lease back to nonprofit groups and/or developers by means of public/private partnership agreements.
- The City owns 2 lots at the corner of Morrison Avenue/Richter Street and a third lot in the middle is owned by West Kootenay Power (WKP). The 3 lots were previously used as a power utility and are zoned accordingly.
- The intent is to acquire the land owned by WKP and initiate a Request for Proposals for a long term arrangement to assist with development of an affordable or special needs housing project on the site.

**<u>R707/00/08/28</u>** THAT Council undertake approval procedures for the draft Housing Opportunities Reserve Fund Bylaw attached to the Planning Department's report of August 24, 2000;

AND THAT funds to assist affordable or special needs housing projects, other than by the provision of land under the requirements of the proposed Housing Opportunities Reserve Fund Bylaw, be made available under the Community Social Development Grant program;

AND THAT the City initiate a Request for Proposals (RFP) for property located at the northwest corner of Morrison Avenue and Richter Street, known as 2490 Richter Street, with the following conditions:

- The City will enter into negotiation with West Kootenay Power to acquire that part of the property owned by the utility;
- Suitable development would consist of the following: boarding home for no more than 10 residents; minor group home; duplex or semi-detached dwellings; or single detached home with a secondary suite, in accordance with the definitions and requirements of the City's Zoning Bylaw 8000;
- Secondary uses of this property might include a minor care centre, in accordance with the requirements of the City's Zoning Bylaw 8000;
- The City will undertake to re-zone the property from P4 to RU6 or RU6b, depending on the proposal that is selected;
- Prospective tenants of the proposed development should fall within the Core Need Income Thresholds established by BC Housing and provided in the City's Housing Resources Handbook;
- Rents should not be above the latest CMHC average rents, provided in the City's Housing Resources Handbook;
- If homes are offered for purchase, the price should not be above the latest starter home price identified by the City in the Housing Resources Handbook;
- Needs groups for housing to be targeted for the development should consist of any of the following groups that fall at or below Low Income Cut-Off levels (see the Housing Resources Handbook):
  - Lone parent families;
  - Couples;
  - Two parent families;
  - Single person households of non-elderly persons;
  - Elderly single person households;
  - Special needs households (i.e. people with disabilities);
- The City will acquire the land and lease it back to the partners responding to the RFP through a long-term lease arrangement;
- The City will enter into a public-private partnership with the successful RFP respondents which will specify the details of the arrangement by the means of a legal agreement registered against the property.

# (BYLAWS PRESENTED FOR ADOPTION)

6.1 <u>Bylaw No. 8448 (OCP97-024)</u> – Official Community Plan Amendment – Marona Estates Ltd. (The Conservatory) **Requires majority vote of full Council (5)** 

Councillor Day advised that this bylaw and the next 2 bylaws on the agenda involve direct members of his immediate family putting him in a conflict of interest and left the Council Chamber at 2:52 p.m.

Council:

The subject bylaw requires 5 affirmative votes to pass and the vote was very close at 2<sup>nd</sup> & 3<sup>rd</sup> readings. It would be in the best interests of the applicant to have all of Council participate in the vote, particularly given that this is such a large controversial project.

Staff:

- Financing is in place to secure road works that the applicant wants to start this fall. If adoption of the bylaws is deferred that would delay those works to next spring and that adds financing costs to the project.
- The applicant is anxious to have the issue resolved and did not exercise the option to withdraw the bylaws from this agenda.

- \$150,000 in the 2003 budget to construct a plaza which will include a fountain;

AND THAT the 2000 Financial Plan be amended to reflect the additional funding requirements;

AND FURTHER THAT the City of Kelowna award the following primary contracts for the construction of the children's waterpark and multifunctional building in Ben Lee Park:

# 9. <u>COUNCILLOR ITEMS</u>

#### (a) <u>Transit Service to Kelowna Airport</u>

Councillor Shepherd noted that Kelowna transit does not go directly into the airport but rather drops off airport passengers at the airport entrance on the highway. Mayor Gray advised that the decision was made years ago based on reasons that may have changed by now and agreed it would be timely to revisit the decision and to raise the matter for discussion at the next Transit Committee meeting.

### (b) <u>Noxious Weeds and Grasses Bylaw</u>

Councillor Shepherd noted that the definition of 'grasses' in the City's Noxious Weeds and Grasses Bylaw is very general and prevents the growth or presence of grasses exceeding 8" high. As the bylaw now reads Bunch Grass and other ornamental plants that are becoming popular in landscaping would not be permitted. Councillor Shepherd asked that staff investigate whether an amendment to the bylaw is warranted to acknowledge and provide for use of native plant species such as bunch grass.

### (c) <u>Triathlon</u>

Councillor Cannan requested a report from staff on the successes and failures from this year's Triathlon to determine whether changes are needed for next year.

### (d) <u>Westbank First Nation</u>

Councillor Cannan suggested that the Mayor send a letter of congratulations to newlyelected Chief Brian Eli. Councillor Hobson added that local government should initiate discussions with the new Chief and Council early on.

#### (e) <u>Electronic Agenda Packages</u>

Councillor Day expressed appreciation for agenda packages now being available to Council electronically and enquired when the maps and other attachments to the reports will also be available with the electronic agenda package. Staff to investigate.

### (f) Knox Mountain Park

Councillor Hobson noted there is no indication of where the easterly boundary of Knox Mountain Park begins and asked that staff consider installing signs to indicate when people are entering the park.
