## 3. PUBLIC IN ATTENDANCE

3.1 Presentation by the Regional District of Central Okanagan's Director of Parks & Recreation, Bill Vos, and Director Len Novakowski re: Gellatly Nut Farm

Len Novakowski, Regional Director:

- Here to seek Council support to buy the nut farm property and turn it into a regional park for public use.
- The Gellatly Nut Farm Society is committed to raise \$800,000 and the Westbank area is committed to raise \$1 million. The other partners in the Regional District of Central Okanagan are being asked to commit to the remaining \$1.4 million.

Councillor Cannan entered the Council Chamber at 1:37 p.m. and took his place at the Council Table.

Bill Vos, Regional Director of Parks & Recreation:

- The property is a Class "A" heritage site.
- The site is 9.88 acres in size with 485 feet of lake frontage.
- About 1/3 of the trees and shrubs on the site will have to be removed over time because they have not pruned for a long time and the dominant trees have canopied out the smaller ones. The site will be pruned as a park not as a farm but the Regional District will ensure the best trees are retained.
- The Regional District of Central Okanagan has to remove or waive all subject to's from the offer to purchase by November 5, 2000.
- The Gellatly Nut Farm Society will pay the \$50,000 deposit. The acquisition must be finalized by mid-2002 or the deposit is non-refundable.

Harold Reay, Regional Director of Finance:

- Explained how funding the remaining \$1.4 million could be shared by the City of Kelowna and other regional partners by imposing a 3 cent levy over a 5-year period.
