4. PLANNING

4.1 Planning & Development Services Department, dated November 22, 2000 re: Development Permit Application No. DP00-10,076 – Dilworth Shopping Centre (Kenneth Takeuchi Architect Inc) – 2339 Highway 97 North (3060-20)

Staff:

- The applicant is proposing changes to the façade of the Dilworth Shopping Centre to accommodate a new tenant, Save On Sports.
- The recommendation to Council is negative because the proposed yellow lettering on the canopy signage is not complementary to the colour theme of the shopping centre.

- If Council cannot approve the proposed signage, then would like the sign removed from the Development Permit (DP) application so that the DP can be issued to allow them to get a building permit and get on with the proposed renovations.

Stacey Hughes, Manager of the new Save on Sports store:

- Emphasized the importance of the blue and yellow corporate colours to the store image.

The consensus of Council was to accept the Save on Sports corporate colours.

6.1 Properties Supervisor, dated November 22, 2000 re: <u>Kelowna Museum – Vinyl Flooring Removal</u>

6.2 Properties Supervisor, dated November 22, 2000 re: <u>Lease Renewal – Kelowna Youth & Family Services</u>

R936/00/11/27 THAT City Council approve extending the lease with SD-14 Ventures Ltd. for the Kelowna Youth & Family Services offices located at Suite 100 - 260 Harvey Avenue, Kelowna, B.C., for a 3-year term at a gross monthly rent of \$2,098.75 with an option for a further 2-year renewal at a base monthly rate to be negotiated at that time;

AND THAT the Mayor and City Clerk be authorized to sign the lease modification agreement.

6.3 Transportation Manager, dated November 20, 2000 re: Glenmore Drive Speed Zones (5460-01)

Staff:

- The staff recommendation is to convert the existing 30 km/hr. speed zone on Glenmore Drive in front of Glenmore Elementary School to 60 km/hr, subject to the upgrading of the High/Summit/Glenmore intersection (expected in spring 2001); and to convert the existing 50 km/hr. speed zone on Glenmore Drive between Harvey Avenue and Mountain Avenue to 60 km/hr.
- This recommendation was triggered by a petition bearing 329 signatures (not 165 as indicated in the report) received by City staff in March 2000 for increasing the speed limit.
- The Glenmore Elementary School Parents Advisory Council (PAC) is opposed to increasing the speed.
- Glenmore is an arterial road and has been designed to accommodate the higher speed limit.
- All issues of concern with respect to safety around the school were corrected when Glenmore was widened.
- Played a video showing traffic movement in front of the school at peak time in the morning.

Council:

- An increased speed limit would make it more difficult for traffic to access Glenmore Drive from Tronson. Since Tronson is the only egress to Glenmore from the school an alternate route may be warranted.
- An increased speed limit could negatively impact children crossing High Road at Lowland and vehicles trying to turn left from High Road onto Lowland.
- Pedestrian safety at the Glenmore/Summit/High Road intersection is of paramount importance.

R937/00/11/27 THAT staff be instructed to proceed with the Glenmore/Summit/High Road intersection design based on the potential 60 km speed limit and report back to Council on potential speed limit changes after the intersection has been constructed.

6.4 Director of Parks & Leisure Services, dated November 23, 2000 re: Community Arts Centre (0760-20)

Staff:

- The fundraising milestone of 90% of the cost has now been reached.
- Would like to start some of the interior demolition work immediately.
- Bridge financing will be required and Council should be aware of the risk. If there is a shortfall there will be pressure on the City to provide the extra funds to finish the project.
- If all goes according to schedule, the facility could open as soon as the first quarter of 2002.

Council agreed to a friendly amendment to the first paragraph of the motion to indicate Rotary Arts Centre instead of Community Arts Centre.

AND THAT Council's authorization is subject to confirmation from the Millennium Bureau of the Government of Canada that the Millennium Grant is available based on the current capital budget and time-line for completion of the project;

AND THAT bridge financing be in place prior to the award of any major construction contracts;

AND THAT all required rezoning, development permits, and building permits be obtained;

AND FURTHER THAT the Kelowna Visual and Performing Arts Centre Society be asked to participate with the City in the development of an appropriate governance and operating model for the Centre prior to hiring a general manager.

8. <u>COUNCILLOR ITEMS</u>

(a) Bank of Montreal – Bernard Avenue/Water Street

Councillor Shepherd announced that the Bank of Montreal has come up with a revised design for their proposed building. The revised plans will be presented for review by the Community Heritage Commission (CHC) this Wednesday at noon. The Acting City Manager confirmed that the Director of Planning & Development Services approves direct Development Permit applications and that the proposed changes will be dealt with by the Director following the review by the CHC.

(b) Okanagan Regional Library Budget

Councillor Day reported that the Okanagan Regional Library budget increase for 2001 was set last Wednesday at 4.25%. That increase maintains the present library service but the cut from the 5.98% requested affects the extension of new services. The Board has agreed that any reduction of service would be on an overall area basis.
