- Disposition of any surplus land at the bottom of the slope needs to be determined before 4th reading.

- There needs to be some reclamation on the site since development will be phased and staff need to investigate whether dust would be considered a health hazard for the adjoining neighbourhoods.
- The proposal now meets the City's requirements for subdivision and safety.
- Do not see approval of this application as precedent setting despite the negative history to this development over the years. Any similar approach to development would not be endorsed by Council.
