6.5 Airport General Manager, dated January 3, 2001 re: <u>2001 Airport Taxi</u> <u>Licence Fees</u> (2320-20; 0550-05)

Staff:

- The review of airport taxi licence fees was initiated because the increased number of licences being process has resulted in higher administrative costs and increased policing required by the commissionaires to ensure the cabs come forward in order.
- Airport taxi operators were consulted on whether to proceed with a closed stand or an open stand taxi operation for 2001 and the decision was made to proceed with the open stand approach.
- The two options considered for an open stand were (1) offer an unlimited number of taxi licences at \$500 each or (2) go out to tender and award a licence to the first 35 with the highest bids.
- The recommendation before Council is to make an unlimited number of licences available and to increase the taxi licence fee from \$150 per year to \$500 per taxi per annum, effective April 1, 2001.
- Inflationary measures will be considered for the future.
- All of the taxi operators with individual licences at the airport have been notified of this meeting and the recommendation before Council.

Council:

- Support the open stand approach but with the fee increase phased in over 3 years.
- The cab industry is already facing big increases in fuel costs and they have already done their planning for the year based on existing licence fees.

Council agreed that it was <u>not</u> necessary to hear the decision of the Motor Carrier Commission before setting the taxi licence fees at the Kelowna Airport.
