## Okanagan Sun – Request for Funding

Staff:

- Okanagan Sun Football Team hosted the Canada Bowl and they received a \$1000 hosting grant from the Mayor.
- Actual Čity costs for set up, moving bleachers and preparation of Apple Bowl estimated at \$14000.
- Okanagan Sun had revenue of \$3935 from beer sales and \$1200 from concession.
- City's revenue of beer sales \$2027.
- Okanagan Sun requesting additional funds equal to the amount owed to the City (\$7038).

Council:

- Need to have policy to deal with assistance for the funding of all national championships held in Kelowna.
- Need to determine what criteria needs to be meet to be eligible for levels of funding and conditions that need to be meet in order for City to become a partner in a large sporting event.
