8. COUNCILLOR ITEMS

(a) Street Cleaning – Highway 97

Councillor Shepherd commended City staff for the good job of street cleaning and suggested that the Ministry of Transportation and Highways be asked to clean the sand from Highway 97 bike lanes.

(b) Design of Bike Lanes at Intersections

Councillor Clark suggested that the way bike lanes have been designed at the intersection of Gordon Drive and Cook Road is creating a dilemma for motorists trying to turn right and is an accident waiting to happen. The City Manager noted that the intersection of Bernard Avenue and Spall Road has been similarly designed with the intention of helping guide cyclists through the intersection. Staff will provide a report on how the new design is working.

(c) Request for Changes to the Motor Vehicle Act

Councillor Clark advised that in Europe, when there is a bike lane to the right of an auto lane, the right-of-way goes to the cyclist. He suggested that Council have a discussion in future about pursuing similar changes to the Motor Vehicle Act via a resolution to the UBCM.

(d) Far West Transit Operations

Councillor Given asked for a progress/status report from Far West on to how transit operations have gone since their assuming the transit contract last year. Request referred to the Transit Committee.

(e) Federal/Provincial Funding – Agriculture Industry

Mayor Gray referred to a letter from the president of the B.C. Fruit Growers Association regarding the federal government's offer to assist people in the agriculture industry across the country. The federal government will contribute 60% of farm income disasters in each province provided that the respective provincial governments will contribute the other 40%. For the province of British Columbia fruit industry, that would require a provincial funding commitment of approximately \$7.2 million. The Fruit Growers Association has asked for a letter of support from Council.
