RECOMMENDATION:

THAT Council approve the recommendations from the Social Planning Board for grants to be allocated under the Community Social Development and Grants to Address the Sexual Exploitation of Youth programs in 2001, as set out in the Tables within this planning report and in accordance with Council Policies 218 and 277.

REPORT:

The process for receiving and reviewing grants under the City's Community Social Development Grant and Grants to Address the Sexual Exploitation of Youth programs is now complete. This process is set out in Council Policies 218 and 277, which are attached to this report. The procedures for each grant program are quite different, but are carried out simultaneously by a sub-committee of the Social Planning Board.

The Grants Sub-Committee concluded its recommendations, following interviews on March 23rd, 2001. Its recommendations were forwarded to the full membership of the Social Planning Board and the majority of the Board has responded in favour of the recommendations.

Council is now requested to approve the recommendations of the Social Planning Board regarding the grants under these two grant programs. The grants that are recommended are summarized in the ensuing tables, according to each grant program. The procedures outlined under Council Policy (218 and 277, attached) will continue to be followed in allocating the grants and administering the programs.
