Rick Dowding, Board of Directors president, and Donna Moore, executive director of the Art Gallery:

- Brought Council up to date on the state of the art gallery
- Requested that their annual funding from the City be increased by \$52,000 to offset rising costs in utilities and to upgrade staff salaries that are still at the 1997 level.

 - 4.1 Planning & Development Services Department, dated May 2, 2001 re: <u>Rezoning Application No. Z01-1011 – Eileen Powell (Henk Van Gurp,</u> <u>Guhue & Van Gurp) – 2830 East Kelowna Road</u> (3360-20; S01-011)

Staff:

4.2 Director of Planning & Development Services, dated April 12, 2001 re: Program for Seasonal Extension for Sidewalk Cafes (6530-12)

Staff:

- The program was approved on a trial basis last year as an extension of food and beverage services for outdoor dining opportunities.
- Given the positive feedback, propose extending the program and formalizing the arrangements so that business owners know the parameters of the program.
- The permit period would be May 15 to October 15 with one patio per block using maximum 2 parallel or 3 angle stalls.

Council:

- Loss of available parking spaces is an issue for other business owners on the street.
- Would people be permitted to rebid on the patio space they had the previous year? If so for how long, if not what would be their incentive to invest in the cost of a patio?
- With the restriction of one patio per block, how would anyone else in a block get approval for a patio once a patio has been approved on the block?
- Applications for additional patios on the same block should be considered on a case by case basis, and maybe ask the Parking Committee to comment.
- There should be provision for two restaurants side by side sharing the cost of a single patio.

Director of Planning & Development Services, dated May 3, 2001 re: Private Moorage Referral – Tescon Developments (6470-20)

Staff:

- Tescon Developments is developing the Capozzi property and have applied for a 108 m long shared moorage facility extending 48 m into the lake with 32 boat lifts.
- The City does not approve docks but comments on referrals from B.C. Assets & Lands who rely heavily on the recommendation they receive from the City.
- Staff are recommending an 88.35 m long shared moorage facility extending 40 m out into the lake with 9 boat lifts.
- The development could potentially have 9 individual docks if each waterfront parcel applied for its own dock and could meet licensing criteria.
- The City's existing shared dock policy addresses single family property owners along the waterfront getting together and constructing one shared dock instead of individual docks. The policy does not anticipate strata residential development.
- The Eldorado Arms strata council are concerned the proposed dock would take on the shape of a marina and they are concerned that people not living on the waterfront lots would have access to the shared dock.
- The City has applied for a Head Lease for the area from Okanagan Lake bridge north to the Riverside mill site but with the pending election do not anticipate hearing back from the province for a while.

Council:

- Prefer to approve the policy before approving the dock.
- Restricting the number of boat lifts permitted on the dock could raise a liability issue if the safety of the boats that are in the water is not addressed and boats are breaking loose from their moorage during a storm.

Councillor Shepherd asked for a report from staff regarding the implications of having the Glenmore landfill site open to the public on Sundays even if at reduced hours and only during certain months.

(d) Baggage Carts at the Airport

Councillor Shepherd expressed concern about people having to pay for the baggage carts at the Airport. Mayor Gray agreed to put the item on an agenda for debate by the Airport Advisory Committee.

(e) Policy re Filling of the Foreshore

Councillor Hobson expressed concern that people are placing fill in the foreshore without permission and then applying to the province to buy that foreshore. He noted this is not accretion but rather acknowledged unnatural filling to create additional land and suggested that City Planning and Environment staff develop a policy to be clear on the City's position with respect to filling of the foreshore, including City water lots.
