## CITY OF KELOWNA BYLAW NO. 8671

## A bylaw to authorize the expenditure of monies in the Capital Works, Machinery and Equipment Reserve Fund for 2001

WHEREAS, there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund established under Bylaw No. 5436-82 of Eleven Million, Five Hundred Seventy-Eight Thousand, Six Hundred Seventy-Nine Dollars (\$11,578,679.00) as at March 31<sup>st</sup>, 2001 which amount has been calculated as follows:

Balance in Reserve Fund at December 31<sup>st</sup>, 2000 \$12,829,922.00

Add: Contributions to March 31<sup>st</sup>, 2001 \$ 60,947.00

Deduct: Commitments outstanding under bylaws

previously adopted \$ 1,312,190.00

Uncommitted balance in reserve fund at March 31<sup>st</sup>, 2001 \$11,578,679.00

AND WHEREAS, it is deemed desirable to expend a portion of the monies set aside under said Bylaw No. 5436-82 for the purpose of general capital expenditures set out below;

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. The sum of Eleven Million, Five Hundred Seventy-Eight Thousand, Six Hundred Seventy-Nine Dollars (\$11,578,679.00) is hereby appropriated from the Capital Works, Machinery and Equipment Reserve Fund to be expended in 2001 for the following purposes:

- 2. The expenditure to be carried out by the monies hereby appropriated shall be more particularly specified and authorized by resolution of Council.
- 3. Should any of the above remain unexpended after the expenditures hereby authorized have been made, the unexpended balance shall be returned to the credit of the Capital Works, Machinery and Equipment Reserve Fund.
