RECOMMENDATION

THAT Council receive the Certificate of Sufficiency dated June 12, 2001 pertaining to Bylaw No. 8673 - Amendment No. 6 to Sewer Specified Area No. 8 Bylaw No. 5373-84 (Rutland/Highway 33);

AND THAT Bylaw No. 8673 - Amendment No. 6 to Sewer Specified Area No. 8 Bylaw No. 5373-84 (Rutland/Highway 33) be advanced for adoption consideration.

BACKGROUND

On April 30, 2001 Council gave the first three readings to Bylaw No. 8673 which proposes to add 77plots to the sewer specified area No. 8. Under the provisions of the *Local Government Act* when the boundaries of a specified area are proposed to be enlarged or reduced, a notice must be published in the newspaper and notices must be mailed to the property owners of the properties that are proposed to be included or excluded from the specified area. To comply with this statutory requirement, on May 10, 2001 a notice was published in the Kelowna Daily Courier and on May 7, 2001 notices were mailed to the affected property owners.

As of the deadline date (June 11, 2001) none of the affected property owners had petitioned against the specified area amendment so Council may consider adoption of the bylaw.
