Road Exchange Bylaw

A bylaw pursuant to Section 525 of the Local Government Act to authorize the City to dispose of a portion of highway, being a portion of Gordon Drive at Lequime Road in exchange for a portion of Part of Lot 3, Plan KAP66568, Section 6, Township 26, ODYD, in the City of Kelowna, British Columbia

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

- The City of Kelowna is hereby authorized to convey to the registered owners of Part of Lot 3, Plan KAP66568, Section 6, Township 26, ODYD that portion of highway shown as Closed Road Parcel "B" lying adjacent to Part of Lot 3, Plan KAP66568, Section 6, Township 26, ODYD comprising 0.202 ha., shown in Bold Black on Plan prepared by Douglas A. Goddard, B.C.L.S., and completed on 28th day of August 2001, for the sum of One Dollar (\$1.00) and other valuable consideration and in exchange for that portion or tract of land described in Paragraph 3 following.
- 2. The said Closed Road Parcel "B" described in the foregoing Paragraph 1 is hereby stopped up and closed to traffic.
- 3. The lands described in Paragraph 1 are conveyed from the Crown Provincial in exchange for the transfer from the registered owners of that portion of Lot 3, Plan KAP66568, Section 6, Township 26, ODYD shown Road Parcel "A" comprising an area of 0.293 ha. shown in Bold Black on Plan referred to in Paragraph 1 above.
- 4. The said Road Parcel "A" described in the foregoing Paragraph 3 shall be established as a portion of highway.
- 5. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.
- 6. Before adoption of this bylaw, public notice of intention shall be given by advertisement pursuant to Section 525 of the Local Government Act.
