Regular Meeting – P.M.

October 22, 2001

A Regular Meeting of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Monday, October 22, 2001.

Council members in attendance were: Mayor Walter Gray, Councillors A.F. Blanleil, R.D. Cannan, B.A. Clark, C.B. Day, B.D. Given and R.D. Hobson.

1. CALL TO ORDER

Mayor Gray called the meeting to order at 1:30 p.m.

2. Councillor Given was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.1 Presentation by Leslie Dieno, Executive Director, Okanagan Regional Library re: <u>Okanagan Regional Library Proposed Budget for Years 2002-2005</u>

Leslie Dieno, Regional Library:

- A similar presentation is being made to all Councils and Regional District boards within the library district.
- The focus for 2002 is on improved public access to library services.
- The per capita levy will be increasing in 2002 from \$28.87 to \$29.39 which will result in the Kelowna tax levy going up by \$140,000 from 2001. On an average value home this would result in about an 88-cent increase going up to about 90 cents per year by the end of this 4-year budget.

Mayor Gray adjourned the meeting to allow members of Council to participate in a ride on a double decker bus that was brought to Kelowna in conjunction with the Transit Convention in Kelowna. The bus was similar to the three double decker buses that will be added to Kelowna's transit fleet next spring. (1:57 p.m.)
