CITY OF KELOWNA BYLAW NO. 8739

Amendment No. 1 to Sewer Specified Area No. 21A Bylaw No. 8658 (MacKenzie Bench)

WHEREAS pursuant to the provisions of the *Local Government Act*, the Council of the City of Kelowna adopted Bylaw No. 8658 establishing Sewer Specified Area No. 21A;

AND WHEREAS pursuant to Section 649 of the *Local Government Act*, Council may by bylaw reduce or enlarge the size of the specified area;

AND WHEREAS the Council of the City of Kelowna has received a petition from the owners of certain properties to have the municipality enlarge the size of Sewer Specified Area No. 21A to undertake the installation of sewer mains and services to the property line on both sides of Mugford Road from the east property line of Lot 1, Plan 15429 to the west property line of Lot 1, Plan 22050 in the City of Kelowna;

AND WHEREAS the Municipal Officer assigned the responsibility for Corporate Administration for the City of Kelowna under Section 198 of the *Local Government Act* has determined the sufficiency of the petition under the provisions of Sections 631 and 632 of the *Local Government Act*,

NOW THEREFORE the Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

- 1. THAT the servicing boundary of Sewer Specified Area No. 21A, established by Bylaw No. 8658, be amended by adding the parcels described below and shown on Map "A" attached to and forming part of this bylaw:
 - Lot B Section 26 Township 26 ODYD Plan 14835 except Plan 17525; and Lots 12 to 15 inclusive Section 26 Township 26 ODYD Plan 17525 all located on Macaden Court, Kelowna, BC;
 - (b) Lot 11 Section 26 Township 26 ODYD Plan 17525; Lots 1 & 2 Section 26 Township 26 ODYD Plan 13147; Lots 13 to 15 inclusive Section 26 Township 26 ODYD Plan 23278; Lot E Section 26 Township 26 ODYD Plan 35641; Lots 1 to 3 inclusive Section 26 Township 26 ODYD Plan 22370; Lot A Section 26 Township 26 ODYD Plan KAP51833; and Lots 1 & 2 Section 26 Township 26 ODYD Plan 22050 all located on Mugford Road, Kelowna, BC;
 - (c) Lots 1 to 9 inclusive Section 26 Township 26 ODYD Plan 15429 all located on Mara Road, Kelowna, BC.
- 2. This bylaw shall come into full force and effect and is binding on all persons as and from the date of adoption.
- 3. This bylaw shall be cited for all purposes as "Bylaw No. 8739, being Amendment No. 1 to Sewer Specified Area No. 21A Bylaw No. 8658 (MacKenzie Bench)".
