BYLAW NO. 8755

A bylaw to authorize the expenditure of monies in the **Capital Works, Machinery and Equipment Reserve Fund for** 2001

WHEREAS, there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund established under Bylaw No. 5436-82 of Twenty-Five Million, Four Hundred Ninety-Two Thousand, Five hundred Thirty-Nine Dollars (\$25,492,539.00) as at September 30th, 2001 which amount has been calculated as follows:

AND WHEREAS, it is deemed desirable to expend a portion of the monies set aside under said Bylaw No. 5436-82 for the purpose of general capital expenditures set out below;

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

The sum of Twenty-Five Million, Four Hundred Ninety-Two Thousand, Five Hundred 1. Thirty-Nine Dollars (\$25,492,539.00) is hereby appropriated from the Capital Works, Machinery and Equipment Reserve Fund to be expended in 2001 for the following purposes:
