3.3 Planning & Development Services Department, dated November 20, 2001 re: <u>Rezoning Application No. Z01-1043 – Marlene R. Collinson</u> (William Ed Collinson) – 551 Sherrydale Crescent

Staff:

- The applicant proposes to construct a 10-bedroom seniors boarding and lodging home on the property.
- The property is located within the Agricultural Land Reserve; however, the property is less than 2 acres in size and was created prior to introduction of the Land Reserve Commission and therefore the property is not subject to restrictions of the use of agricultural land within the ALR.
- Valley Road is considered the boundary between the urban development to the north and west and the rural land uses to the south and east.
- City Planning documents and policies do not support urban land uses on the east side of Valley Road.
- Planning Department staff cannot support this application and recommend that City Council not give the application initial consideration. If the application does proceed, then considerable pre-planning work should be done and a Development Variance Permit would be required to vary the servicing standards of the Subdivision Development and Servicing Bylaw for the proposed site development.

Ed Collinson, applicant:

- Initial discussions with City staff about the proposed development indicated that there should not be any major hurdles to overcome because water and sewer services were readily available.
- The application has been reviewed and supported by the Advisory Planning Commission.
- The subject property is adjacent to a pear orchard that was planted 65 years ago. The orchard is totally uneconomic. Anticipate that the trees will be pulled out in a couple of years and that the land will be put into hay production. The proposed seniors development would have little impact on that type of farm use.
- Hopefully Council will reduce the requirements of the Works & Utilities Department which appear onerous for the small project that is proposed.
- There would be no more run-off into Brandts Creek than exists now as a result of the proposed development.
- Do not think Sherrydale Crescent would ever be a collector road.
- Report says driveway access would not be permitted onto Glenmore Road; the subject property is a long way from Glenmore Road so that must be an error.
- There are already other small pockets of development encroaching into the agricultural area and so the proposed development would not be precedent setting.
- The existing home would be torn down if the proposed development proceeds.
- The property is 1.54 acres in size. The horses that are currently being boarded on the site and the existing riding ring would hopefully remain.
