1.0 RECOMMENDATION

THAT Council support patron participant entertainment for Chicago Grill Restaurant;

AND THAT Council direct staff to forward the appropriate resolution to the Liquor Control and Licensing Board in Victoria.

2.0 SUMMARY

The applicant seeks Council support for patron participant entertainment for Chicago Grill Restaurant. The applicant would like to offer dancing for patrons. The entertainment endorsement will require the sale of liquor to cease by midnight.

3.0 BACKGROUND

3.1 The Proposal

The applicant recently renovated the restaurant, located at the corner of Water Street and Harvey Avenue and currently holds a Class B – “Dining Room or Dining Lounge” liquor license. He would now like to offer dancing for patrons, which requires a Council resolution. Offering participant entertainment such as dancing will limit the hours of liquor sales, and the applicant will have to cease the sale of liquor at midnight, should he receive the entertainment endorsement. The applicant has also applied for a Designated Food Optional Seating (DFO) area, which does

not require a Council resolution, since Council opted to reply “no comment” to all DFO requests under Policy 295.

5.0 PLANNING AND DEVELOPMENT SERVICES DEPARTMENT

The Planning and Development Services Department has no concerns regarding the proposed participant entertainment endorsement.
