#### 1.0 <u>Recommendation</u>

THAT OCP Bylaw 8600, as outlined in the report of the Planning and Development Services Department dated November 28, 2001, be received for information and forwarded for initial consideration by Council.

#### 2.0 Background

An Official Community Plan (OCP) is a general statement of the broad objectives and policies of a local government respecting the form and character of existing and proposed land use and servicing requirements. Typically, OCPs are reviewed every five years. Each review of the OCP must comply with the Local Government Act (LGA), which stipulates content and process requirements. On February 1<sup>st</sup>, 1999 Council gave formal direction for staff to initiate the most recent review and update of the City's Official Community Plan (OCP).

#### 3.0 <u>Process</u>

The review of the OCP involved significant public and agency consultation, in accordance with Council's OCP Consultation Policy No. 296.

In the summer and fall of 1999 a series of focus groups met to discuss the major OCP topics. The input of the focus groups was reflected in subsequent Discussion Papers, which were presented to the public at an Open House in November 1999. Open Houses were held as follows:

- June 5, 1999 initial data presentation and information gathering.
- November 27, 1999 display of information assembled in Discussion Papers.
- May 18 / May 25 / June 1 / June 8, 2000 display of growth strategy, land use and transportation plan information.
- June 22, 2000 display of first draft OCP (June 12, 2000 version).
- Jan. 17, 24 and 31, 2001 display of second draft OCP (Dec. 8, 2000 version).

Exit surveys were used at each session to gather public comment.

Following the preparation of each of the draft OCP versions the document was circulated to a lengthy list of provincial agencies, utility agencies, first nations, and residents associations. Attached is a list of the agencies and groups to which the draft OCP has been referred for comment (Attachment # 1).

In addition to external agencies and stakeholders the draft OCP was also vetted through several Council committees. Presentations to the Social Planning Board (October 10, 2000) and Advisory Planning Commission (May 15, 2001) were well received and resulted in the Committees' concurrence with the overall OCP direction. A presentation to the Agricultural Advisory Committee (AAC) on June 6, 2001 resulted in a minor policy amendment and AAC endorsement of the overall agricultural policy direction, including recent amendments based on Land Reserve Commission comments. Presentation to the Town Centre Implementation Committee suggestions and at the June 8, 2001 meeting the Committee supported the OCP Urban Centres policies moving on to first reading.

Council undertook a major review of the first draft throughout September, October and November 2000. That review, plus continued consultation and discussion with staff, outside agencies and the public, resulted in revisions that were reflected in the second draft (December 8, 2000). Attached to this report is a summary of the text and mapping changes made as a result of the fall 2000 Council review and agency / public input (Attachment # 2).

Summaries of all the Open House, agency and public input have been placed in the Council Reader file. This material has been edited to remove all reference to the 20-Year Major Road Network and Future Land Use designations, which Council cannot consider at this time (for the reasons noted below). In addition, all of this material has been placed in an OCP binder, available in the Clerks Department, for perusal by any interested members of the public.

On March 26, 2001 Council directed that No. 3 of the Official Community Plan Consultation Policy No. 296 attached to the Planning and Development Services report of March 21, 2001 be amended to add "(d) Holding a workshop to discuss the Pandosy / Richter one-way couplet with affected business stakeholder groups". Required consultation on the Pandosy / Richter Street one-way couplet system has not yet been completed. Staff are seeking additional information to facilitate discussion of this topic and that information is not expected for several months. Unfortunately, the unresolved transportation questions are closely related to other components of the OCP (Future Land Use and Financing provisions). Until the transportation questions are resolved it will not be possible, under Local Government Act provisions, to forward affected OCP portions for Council's consideration.

Rather than holding off on the OCP in its entirety, it is proposed that the policy content of the draft OCP (those portions not affecting the transportation network and therefore the financing strategy) be brought forward for Council's consideration at this time, as a new bylaw 8600.

# 4.0 <u>Content</u>

The proposed Bylaw 8600 dated November 1, 2001 provides updated policies for the 1994 – 2013 timeframe. The 20-Year Major Road Network Plan, the Future Land Use Chapter and Map, and the Financing Chapter remain as they are in the current OCP but are incorporated into the new bylaw (the original chapters and maps have been renumbered to fit with the new format). The proposed Bylaw 8600 is attached to this report (Attachment # 3).

The new 20-Year Major Road Network Map, Future Land Use Chapter / Map and Financing Chapter of the draft OCP have been set aside in order to proceed with the adoption of the remainder of the OCP. The draft OCP material on the 20-year road network, future land uses and financing, as well as an expansion of the timeframe to 2020, will be brought forward at a later date when the related consultation and financial plan work has been completed.

This OCP is not intended as a complete rewrite of the 1995 OCP, but rather, as an update and revision based on new information, but still embodying the goals and objectives of the 1992 Strategic Plan and the 1995 OCP. The major differences between the 1995 OCP and the proposed OCP Bylaw 8600 are:

- Removal of all of the background material and mapping not required by the Local Government Act, and retaining the policy statements, development permit guidelines, and relevant mapping.
- Cross-referencing, removal of duplication and re-organization to make the document more user friendly, and ultimately web friendly (e.g. locating relevant Development Permit Guidelines within each chapter rather than in a separate chapter).
- Addition of a definitions section.
- Provision, as per legislative requirements, of a Regional Context Statement, which indicates how the OCP complies with and implements the Regional Growth Strategy Bylaw.
- Addition of a new chapter on Growth Management, which outlines the overall principles of managing growth.
- Modifications to the Urban Centre / Urban Village boundaries, including changes in terminology (now Urban Centres / Village Centres as opposed to Town Centres / Residential Urban Villages).
- Removal of Environmental policies covered by provincial statute or other City bylaws.
- Change in terminology regarding watercourse protection (now Riparian Management Areas as opposed to Stream Protection Corridors).
- Separation, as per legislative requirements, of the Natural Environment and Hazardous Condition Development Permit areas, including Wildland Fire Hazard.
- Re-organization of the Environment Chapter, including relocation of Public Routes of Access and Shore Zone policies to the Parks and Leisure Chapter.
- Incorporation, as per legislative requirements, of policy statements on Affordable, Special Needs and Rental Housing.
- Re-organization of the Social Environment Chapter to focus on Accessibility, Child Care, Community Development, Crime Prevention and Human Rights. Social policy statements on Arts and Culture, Education, Employment, Health and Housing have been relocated to other chapters.

#### 5.0 <u>Referrals</u>

The Local Government Act (LGA) requires that OCP Bylaws, including major amendments, must be referred to the Land Reserve Commission (LRC) for approval prior to the Public Hearing. The LGA also requires that an OCP include a Regional Context Statement where a Regional Growth Strategy has been adopted by the Regional Board and that the Regional Context Statement be referred to the Regional Board for their consideration and acceptance.

OCP Bylaw 8600 has been tentatively scheduled for Public Hearing on March 5, 2002 in order to provide time for both the LRC and Regional Board to review and approve the Official Community Plan.

#### 6.0 <u>Conclusion</u>

The proposed Bylaw 8600 and related background material are being introduced now to give Council time to become familiar with the large volume of information. It is suggested that First Reading of Bylaw 8600 occur in two weeks. It is recommended that OCP Bylaw 8600, as outlined in the report of the Planning and Development Services Department dated November 21, 2001, be received for information and forwarded for initial consideration by Council (tentatively scheduled for Dec. 17, 2001).

# Changes to Draft OCP for Council Reference

Staff have continued to edit and revise the Draft OCP to clarify, remove duplication etc., based on Council input, public and referral agency input, as well as legislative services review based on the new Local Government Act (LGA). There have been minor wording changes to clarify policies throughout the document. The wording has also been updated to reflect the recent name changes for several provincial ministries.

Most of that draft material has been brought foreword as a new Bylaw 8600. Only the 20-Year Major Road Network Plan, the Future Land Use Chapter and Generalized Future Land Use Map, and the Financing Chapter, have been retained from the current OCP. All page numbers refer to the consolidated Schedule A for Bylaw 8600.

The most significant change has been to remove all of the background text and mapping so that the proposed Bylaw contains only chapter by chapter policy statements, applicable development permit guidelines and relevant mapping.

Addition of **Definitions** - pages 4 - 7

Chapter 1 - Introduction - Section on Relationship to Other Plans - pages 9 & 11

- Indicate Sector Plans, Neighbourhood and Area Structure Plans as "nonstatutory documents" (not required by the LGA).
- Only specific "OCP related policies and Future Land Use designations" will be brought forward as an OCP amendment.

#### Chapter 1 – Introduction – Section on Development Permits - page 12

- Development Permits refer to "general" form and character only
- All design guideline documents previously adopted into the OCP are too specific under the Local Government Act and should be removed and adopted by resolution in a separate Council policy, with direction to staff to continue to use them as tools to evaluate applications.
