Mayor Gray called the meeting to order at 1:30 p.m.

2. Councillor Blanleil was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.1 Presentation by Mr. Bill Downing, British Columbia Government Employees' Union re: Community Charter – Community Service Impacts and Economic Markers

Bill Downing:

- Concerned about the significant impact of proposed cut-backs in Provincial Government services on jobs and the local economy and the ability to respond to community needs.
- Concerned that services provided by provincial agencies will be downloaded to local government.
- Urged Council to adopt a resolution similar to the draft resolution in Council's agenda package.

THAT the draft Local Government resolution provided by the BCGEU be adopted with the following amendments:

- Insert, a new first WHEREAS clause to state that local government recognizes and supports the intent of the Provincial Government to balance the provincial budget;
- Amend the third BE IT THEREFORE RESOLVED clause by deleting the words "and families without ensuring program integrity and".

AND WHEREAS the roles, rights and responsibilities of local governments will be redefined by the Fall of 2002 through the new Community Charter;

AND WHEREAS the Provincial Government has announced its intentions to shift primary support for key social services to communities and families;

AND WHEREAS the Provincial Government has further announced its intentions to reduce program funding for services such as child protection, environmental services and aboriginal services by as much as 50%;

AND WHEREAS the provincial economy is in a fragile state and a dramatic reduction in community support services and funding may only further the economic instability;

THEREFORE BE IT RESOLVED THAT the City of Kelowna call on the Provincial Government to ensure full community consultation on program reviews and funding reductions;

AND BE IT ADDITIONALLY RESOLVED THAT the City of Kelowna request the Union of British Columbia Municipalities to address this issue with the Provincial Government:

AND BE IT FURTHER RESOLVED THAT the Provincial Government not off-load current provincial program responsibilities onto communities without adequate funding;

AND BE IT FINALLY RESOLVED that any transitions in program funding or delivery be done on a schedule that is respectful to the service recipients, program providers and local economies.
