7. COUNCILLOR ITEMS

(a) Abbott Street Road Closure

Councillor Shepherd noted that at a recent meeting of the Community Heritage Commission, City staff gave a presentation on plans for the Abbott Street recreation corridor and advised that Abbott Street would be closed from Park Avenue to Harvey Avenue for approximately 3 months for construction. That prompted a number of those present at the meeting to raise the issue of left hand turns from Abbott Street onto Harvey Avenue. Councillor Shepherd suggested that this closure period would be an opportune time for staff to gauge the impact of taking away that left turning movement.

Councillor Blanleil added that once a turning movement is closed it can be difficult to get it reopened and suggested that staff should not come back with a recommendation to permanently remove the left turning movement unless they are confident that the public's need for left turn access onto the highway in this area can be met by alternate intersections for the next 5-6 years.

Councillor Shepherd advised she has been contacted by a parent who has heard that the graffiti in Ben Lee Park is to be painted over. The parent was concerned that this will include the areas where art work has been endorsed by Council. Acting City Manager to investigate.

Councillor Cannan informed Council that the deadline for resolutions for the May 2002 convention is March 1st.

(d) Regional District of Central Okanagan Board Meetings

Councillor Hobson, as Chair of the Regional District Board, thanked the City of Kelowna for hosting Regional board meetings in the Council Chamber of City Hall for the past number of years. The Regional Board will now be meeting in their own Board Room at the Regional District offices.
