BYLAW NO. 8795

Amendment No. 2 to Sewer Specified Area No. 21A Bylaw No. 8658 (McKenzie Bench)

WHEREAS pursuant to the provisions of the *Local Government Act*, the Council of the City of Kelowna adopted Bylaw No. 8658 establishing Sewer Specified Area No. 21A;

AND WHEREAS pursuant to Section 649 of the *Local Government Act*, Council may by bylaw reduce or enlarge the size of the specified area;

AND WHEREAS the Council of the City of Kelowna has received a petition from the owners of certain properties to have the municipality enlarge the size of Sewer Specified Area No. 21A to undertake the installation of sewer mains and services to the property lines on both sides of Langford Road from Highway 33 East to Madsen Road; on both sides of Madsen Road from the west property line of Lot 3 Plan 22050 to the east property line of Lot 6 Plan 22370; and on both sides of Muir Road from the south property line of Lot 13 Plan 15377 to the west property line of Lot 9 Plan 15377 in the City of Kelowna;

AND WHEREAS the Municipal Officer assigned the responsibility for Corporate Administration for the City of Kelowna under Section 198 of the *Local Government Act* has determined the sufficiency of the petition under the provisions of Sections 631 and 632 of the *Local Government Act*;

NOW THEREFORE the Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT the servicing boundary of Sewer Specified Area No. 21A, established by Bylaw No. 8658, be amended by adding the parcels described below and shown on Map "A" attached to and forming part of this bylaw:
 - (a) Lots 1 and 32 Section 26 Township 26 ODYD Plan 15377 both located on Highway 33 East, Kelowna, BC;
 - (b) Lots 2 to 8 inclusive and Lots 26 to 31 inclusive Section 26 Township 26 ODYD Plan 15377; and Lots 7 & 8 Section 26 Township 26 ODYD Plan 22370 all located on Langford Road, Kelowna, BC;
 - (c) Lots 3 to 8 inclusive Section 26 Township 26 ODYD Plan 22050; and Lots 4 to 6 inclusive Section 26 Township 26 ODYD Plan 22370 all located on Madsen Road, Kelowna, BC; and
 - (d) Lots 9 to 13 inclusive and Lots 24 & 25 Section 26 Township 26 ODYD Plan 16377 all located on Muir Road, Kelowna, BC.
2. This bylaw shall come into full force and effect and is binding on all persons as and from the date of adoption.
3. This bylaw shall be cited for all purposes as "Bylaw No. 8795, being Amendment No. 2 to Sewer Specified Area No. 21A Bylaw No. 8658 (McKenzie Bench)".
