Mayor Gray reconvened the meeting in open session at 10:55 a.m.

4.1 <u>Meeting with Ministry of Transport Officials in Victoria</u>

- Mayor Gray and the City Manager reported on a meeting they had with the Minister
 of Transport and her staff in response to her challenge to find a way to raise the
 money to allow the Okanagan Lake bridge project to proceed.
- The Minister was asked to consider increasing the Coquihalla poll for passenger cars and imposing a one cent gas tax within the area from Swan Lake to Penticton. The revenue could potentially be sufficient to not only proceed with the bridge project but also for 4-laning the highway by Penticton and 4-laning the highway from Woodsdale to Oyama.
- The Minister agrees the Okanagan Lake bridge is a priority and wants to see the project move ahead.
- The Minister wants to shift the decision making on where money is going to be spent to regional transportation committees and this could be a pilot project for such a committee.

4.2 Access Management Pilot Project – Enterprise Way Extension

- The next phase of development on the Cambridge property cannot occur until the Enterprise Way extension is complete.
- The road extension is also a priority for the Ministry of Transportation as it would reduce traffic demands on Highway 97.

Council:

- This is a case where planning and transportation are connected and is an opportunity for the City to look at the big picture and plan in advance.
- Staff to organize a workshop session with Council to talk about pending development activity impacted by this transportation corridor.
- City Manager to consider whether there is a role for City staff to play with the Ministry of Transportation to help achieve the City's objectives for development in the Rutland Town Centre.

4.3 Council Committee Review

 Mayor Gray and the City Manager will be meeting with each member of Council and each staff liaison for the various committees. The object is to review what the committees are doing and see if there are things that should be done differently.

4.4 'Moving Beyond Planning' Conference
