3.2 Director of Planning & Development Services re: Petitions – How They Get to Council

- Sometimes petitions are received prior to the actual application even coming in and petitions are received by various departments and by various methods. So that they do not fall through the cracks, staff will try to channel the development related petitions to the Clerk's Department.
- When petitions are received prior to the application going to APC, often a lot of the concerns get addressed before the application advances to Council making the validity of the petition questionable.
- A single letter is actually a petition. Staff do not want to be the arbitrators of what should or should not be circulated to Council.
- Planning Department staff are now advising people at the APC meetings that if they want anything they have brought forward at APC to go to Council, they will have to watch for when the application is advertised to a Council meeting and then resubmit. Clerk's Department staff are also telling people bringing in letters or petitions when they are too early and the process they should follow if they want their submission to
- go to Council. Staff are telling people who ask about submitting petitions the most effective way of that petitions can be dealt with
- The date will be added to the general petition to that Council can see the signatures were obtained in addition to the date when the petition was received by the City.
- Will send out a reminder to all the departments that receive petitions for other than development applications to follow the Council policy that is in place.
