#### **RECOMMENDATION:**

THAT City Council award all eleven areas of the subject contract to the low bidder Royal Star for three (3) years, for a total lump sum bid price of One Million, One Hundred and Fourteen Thousand, Seven Hundred and Ninety-eight Dollars (\$1,114,798.00) plus G.S.T.

### **BACKGROUND:**

The current contracts for Parks Landscape Maintenance expires April 30, 2002. Our Purchasing Department issued tenders and four companies submitted bids as summarized by the chart below.
