## 1. CALL TO ORDER

Mayor Gray called the meeting to order at 1:35 p.m.

2. Councillor Shepherd was requested to check the minutes of the meeting.

# 2.1 Unauthorized Demolition of Hewetson School Building - Pandosy Street

Mayor Gray confirmed that demolition of the former Hewetson School building occurred early this morning. City Bylaw Enforcement staff attended the site at 7:20 a.m. and found the building demolished and the equipment already moved off-site. The building was identified in the City of Kelowna Heritage Registry and no Demolition Permit was issued. The demolition is a flagrant violation of City of Kelowna bylaws and will not be tolerated. The City Solicitor will be advising Council on what action can be taken.

# 2.2 2002 Memorial Cup Champions

Mayor Gray donned a Kootenay Ice jersey and explained that, in keeping with his challenge with the Mayor of Cranbrook, he would be wearing the jersey for the duration of this meeting in recognition of the Kootenay Ice hockey team beating out the Kelowna Rockets in the Western Conference finals and going on to win the Memorial Cup in Guelph, Ontario on the weekend.

# 4. UNFINISHED BUSINESS

- 4.1 (a) Request for <u>Financial Assistance 2002 ROAR HydroFest</u>
  - (b) Events and Facilities Supervisor, dated May 22, 2002 re: <u>ROAR HydroFest 2002</u>

### Staff:

- Responded to Council's questions from the May 13th Regular Meeting when this request was first considered advising that the event is sponsored by the Kelowna Unlimited Hydroplanes Society but a for-profit company is contracted for the management of the event. The Kelowna Unlimited Hydroplanes Society status is non-active at the present time but they are taking steps to get their non-profit society status back to active. The event organizers are working with the Yacht Club, the Downtown Kelowna Association, Kelowna Marina, and The Grand Hotel to address any concerns they have; no major concerns have been identified to the City. City-related costs that would have to be paid as part of the event include RCMP, Fire, park rental for the week, and City equipment and services for set-up for the event, and are estimated at \$33,300. A Sports Development Grant has already been approved in the amount of \$5,000 leaving \$28,300 as final amount to be paid.
- Waiver of the \$12,600 park rental fee would have no negative impact on the City of Kelowna budget as it was not a projected cost in the budget. Funds are not currently available in the 2002 budget for the other costs.

## Council:

 Discussed whether it was appropriate to be considering the request for fee waivers in advance of the event rather than waiting until after the event when final figures come forward, as is normal practice.

7.6 Parks Manager, dated May 14, 2002 re: <u>Dehart Community Park Master</u> Plan (6140-20)

## Staff:

- When a Development Variance Permit application for a covered tennis facility on the Mission Community Hall site was denied by Council, the Okanagan Mission Community Hall Association (OKMCHA) was asked to consider revising their proposal and staff were directed to proceed with a master plan for the entire park site (the area south of Dehart Road between Lakeshore Road almost to Gordon Drive) to determine whether the site is appropriate for a tennis facility and if so, where it should go.
- All key stakeholders have been consulted.
- The options being considered for preparation of the master plan are brought forward more as information at this time; the master plan will be brought back in future for adoption when the City is in a position to proceed with development of the park.
- Development of the park is not envisaged for a number of years because land acquisitions are still required.
- The OKMCHA tennis club have advised that they are considering bringing back a revised proposal but are not ready to do so at this time.

## Bob Evans, TRUE Consulting:

- The park site is approximately 7.9 acres in size; however, some of the lands are still in private ownership.
- Preparation of a park master plan was requested in order to consider how a proposal by the tennis club would impact the City's ability to develop the remainder of the site.
- After extensive public consultation to determine the facilities the public deemed to be important, 3 options were developed to show conceptually how the desired facilities could be accommodated on the park site.
- Presented the 3 concepts.

## Staff:

- Based on community feedback, recommend support for Option 1A which does not include a covered tennis facility.
- Expect to hear from the OKMCHA soon as to whether they wish to proceed. If they can come up with a covered facility along with the new exterior courts that is supportable by the City, then recommend Option 1B be considered by Council.

## Council:

- The OKMCHA will be holding a general meeting on June 3, 2002 to see if their membership wishes to continue to pursue a tennis facility on the site. Agreed to hear the results of the June 3<sup>rd</sup> meeting before deciding on an option to
- pursue.
- It may be appropriate to consider staged development of the park site, once an option is approved for preparation of the Park Master Plan.

Councillor Nelson initiated discussion regarding his concern that the City of Kelowna taxpayers are paying a portion of the Regional District Directors' (outside Kelowna) wage and expenses. Councillor Clark stated he also opposed the remuneration paid to the City of Kelowna Councillors who are appointed to the Regional Board. Councillor Hobson, Chair of the Regional Board, explained how the inequity of the Regional District Directors' wage and expenses has been addressed by the Regional Board for next year. The remuneration of the City Councillors issue is one that is the responsibility of the Regional District Board.

### Dilworth Crescent/Bernard Avenue Intersection (c)

Councillor Cannan noted that there was an accident at Bernard Avenue/Dilworth Crescent last week and asked that staff investigate options to avoid a potentially serious accident at that intersection. The City Manager noted there was an accident at that location over the weekend as well and agreed to investigate.
