CHAIRMAN WILL CALL THE HEARING TO ORDER:

1. (a) The purpose of this Hearing is to consider certain bylaws which, if adopted, shall amend Zoning Bylaw No. 8000.
  - (b) All persons who believe that their interest in property is affected by the proposed bylaws shall be afforded a reasonable opportunity to be heard or to present written submissions respecting matters contained in the bylaws that are the subject of this hearing.
  - (c) All information, correspondence, petitions or reports that have been received concerning the subject bylaws have been made available to the public. The correspondence and petitions received after May 24, 2002 are available for inspection during the course of this hearing and are located on the information table in the foyer of the Council Chamber.
  - (d) Council debate on the proposed bylaws will take place when they are considered by Council during the Regular Council meeting after the conclusion of this Hearing.
  - (e) It must be emphasized that Council will not receive any representation from the applicant or members of the public after conclusion of this Public Hearing.

3. INDIVIDUAL BYLAW SUBMISSIONS:

3.1 **BYLAW NO. 8825 (Z01-1061)**

<b><u>LOCATION:</u></b>	<b>West of Hollywood Road North</b>
<b><u>LEGAL DESCRIPTION:</u></b>	<b>Part of Lot A Section 2 Township 23 ODYD Plan KAP55855 except Plans KAP63299 and KAP63302</b>
<b><u>OWNER/APPLICANT:</u></b>	Georg-Michael Holzhey Ltd. (John Hertay)
<b><u>PRESENT ZONING:</u></b>	A1 – Agriculture 1
<b><u>REQUESTED ZONING:</u></b>	I1 – Business Industrial and RU5 – Bareland Strata Housing
<b><u>PURPOSE:</u></b>	To permit the development of 2 industrial lots and a ±74-lot bareland strata modular home subdivision.

3.2 **BYLAW NO. 8862 (Text Amendment No. TA02-0002)**

<b><u>APPLICANT:</u></b>	City of Kelowna
<b><u>PURPOSE:</u></b>	Amendment to the A1 – Agriculture 1 zone that increases the minimum lot size required for newly subdivided properties zoned A1, situated outside of the Agricultural Land Reserve (ALR), from two hectares (five acres) to four (ten acres). The minimum lot size required for properties zoned A1, located inside the ALR remains at two hectares (five acres).

4. PROCEDURE ON EACH BYLAW SUBMISSION:

- (a) Brief description of the application by City Staff (Planning).
- (b) The Chairman will request that the City Clerk indicate all information, correspondence, petitions or reports received for the record.
- (c) The applicant is requested to make representation to Council regarding the project and is encouraged to limit their presentation to 15 minutes. Where appropriate, the applicant should have sufficient visual aids, e.g. schematics, sketches, etc. to describe the project to the Council and to the public in attendance.
- (d) The Chairman will call for representation from the public in attendance.
  - (i) The microphone at the podium has been provided for any person(s) wishing to make representation to the meeting.
  - (ii) The Chair will recognize ONLY speakers at podium.
  - (iii) Speakers are encouraged to limit their remarks to 5 minutes. However, if they have additional information they may address Council again after all other members of the public have been heard a first time.
- (e) Members of Council may ask questions of the applicant and/or City Staff in order to clarify details of the project, etc.
- (f) Final calls for representation.
