1.0 <u>RECOMMENDATION</u>

THAT Council support patron participant entertainment for the Blue Gator Bar & Grill;

AND THAT Council direct staff to forward the appropriate resolution to the Liquor Control and Licensing Board in Victoria.

2.0 SUMMARY

The applicant seeks Council support for patron participant entertainment for the Blue Gator Bar & Grill. The applicant would like to offer dancing for patrons. The entertainment endorsement will require the sale of liquor to cease by midnight.

3.0 BACKGROUND

3.1 The Proposal

The applicant is asking Council to support the Blue Gator Bar & Grill offering entertainment at their new location at 441 Lawrence Avenue. Similar to the existing operation at 1675 Abbott Street, the new restaurant will include a dance floor, and live entertainment and dancing will be offered. Participant entertainment such as dancing will limit the hours of liquor sales, and the applicant will have to cease the sale of liquor at midnight, should he receive the entertainment endorsement. The seating capacity of the restaurant will be approximately 85 persons. The old location will remain a restaurant with entertainment and will be operated under a new name.

4.0 TECHNICAL COMMENTS

The application was circulated to several department and agencies, and the following comments were received:

4.1 Inspection Services

The existing washrooms will accommodate 100 persons, and the exiting is sufficient. The maximum occupant load at 1.2 m/person permits occupancy of 85 persons.

4.2 Public Health Officer

No objection to the proposed liquor license provided that the applicant receives an approved food premises operating permit from our department. Currently there are no approvals.

4.3 RCMP

The RCMP has no objections to the proposed entertainment endorsement. The applicant already has a licence in the downtown core.

4.4 Fire Department

The Fire Department has no concerns with the liquor licence application.

5.0 PLANNING AND DEVELOPMENT SERVICES DEPARTMENT

The Planning and Development Services Department has no concerns regarding the proposed participant entertainment endorsement.
