## CITY OF KELOWNA BYLAW NO. 8818

## Road Exchange Bylaw 5440 Chute Lake Road

A bylaw pursuant to Section 525 of the Local Government Act to authorize the City to dispose of a portion of Chute Lake Road for a portion of Lot A Sec 23 Twp 28 SDYD Plan 29585 and Lot 1 Sec 23 & 24 Twp 28 S.D.Y.D. Plan 41091

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

- The City of Kelowna is hereby authorized to convey to the registered owners of Lot A Section 23 Township 28 SDYD Plan 29585 Except Plans 32591, KAP57685, KAP60948, KAP61235, KAP62035, KAP62918, KAP63414, KAP65636, KAP66702, KAP67007, KAP69665, KAP69870, KAP70252, KAP70501, AND KAP\_\_\_\_ and Lot 1 Sections 23 & 24 Township 28 S.D.Y.D. Plan 41091, that portion of highway comprising 0.535 Ha, shown in bold black as Parcel 1, on the attached Reference Plan prepared by Bruce H. Davies, B.C.L.S., and completed on the 10<sup>th</sup> day of June, 2002, for the sum of One Dollar (\$1.00) and other valuable consideration and in exchange for that portion or tract of land described in Paragraph 3.
- 2. The said Parcel 1 described in Paragraph 1 is hereby stopped up and closed to traffic.
- 3. The lands described in Paragraph 1 are conveyed from the Crown Provincial in exchange for the transfer from the registered owners of that portion of Lot A Section 23 Township 28 SDYD Plan 29585 Except Plans 32591, KAP57685, KAP60948, KAP61235, KAP62035, KAP62918, KAP63414, KAP65636, KAP66702, KAP67007, KAP69665, KAP69870, KAP70252, KAP70501, AND KAP\_\_\_\_ and Lot 1 Sections 23 & 24 Township 28 S.D.Y.D. Plan 41091 comprising an area of 1.06 Ha, 169 m² and 509 m² respectively and shown in bold black as Parcels 2, 3 and 4 on the Reference Plan referred to in Paragraph 1 above.
- 4. The said lands described in Paragraph 3 as Parcels 2, 3 and 4 shall be established as a portion of highway.
- 5. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.
