	A bylaw pursuant to Section 525 of the Local Government Act to authorize the City to dispose of a portion of highway, being a portion of Valiant Road in exchange for a portion of Lot B, Plan and Lot C, Plan KAP in the City of Kelowna, British Columbia
	THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, by enacts as follows:

The said Closed Road described in Paragraph 1 above is hereby stopped up and closed 2. to traffic.
