A Regular Meeting of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Monday, October 21, 2002.

1. CALL TO ORDER

Mayor Gray called the meeting to order at 1:34 p.m.

2. Councillor Blanleil was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.1 Charity Redman, Central Okanagan YM-YWCA re: 7th Annual YWCA Week Without Violence – October 20-26, 2002

Charity Redman, YM-YWCA:

- The week without violence encourages the community to put an end to violence.
- Asked that Council take a stand against all forms of violence within the Central Okanagan.
 - 3.1.1 Steve Francis, Community Development Coordinator, Canadian Blood Services re: Kelowna / Prince George Challenge for Donating Blood

Steve Francis, Community Development Coordinator, Canadian Blood Services:

- The success of the city-against-city challenge between Kelowna and Prince George for blood donations has been noted from coast to coast in Canada.
- Expressed appreciation on behalf of people needing blood for the thousands of lives saved.
 - 3.2 Lesley Dieno, Executive Director and Don Nettleton, Financial Manager of Okanagan Regional Library re: <u>Library's Upcoming Budget</u>

Don Nettleton, Financial Manager:

- Update on library activities over the past year and projected activities that will impact future library budgets.
- Over the next 5 years looking for increases of about \$1.00 to \$1.50 per average value home per year.
- Kelowna has had significant library improvements over the past 5-6 years the additional books and materials will impact Kelowna.

Council's Representative on the Okanagan Regional Library Board:

- The 5-year financial plan the library board has prepared proposes a 3.99% budget increase for this year; 4% for 2004; 3.99% in 2005; 4.98% in 2006; and 2.93% in 2007. Each year the budget must be passed by the Board so if there are issues such as a downturn in the economy, the plan can be varied. The board also prepared a strategic plan and it is tied to the 5-year financial plan.
- The Okanagan Regional Library budget will be discussed by the library board this coming Wednesday. Kelowna holds 1/3 of the weight for voting because of the population and assessment value in Kelowna.
- Asked if Council had any advice on how to vote when the budget is discussed by the library board.

Council:

Generally agreed they would prefer about 1% less than the proposed 3.99% increase for this year but left it to the discretion of their Council representative to vote appropriately.

4. UNFINISHED BUSINESS

- 4.1 <u>Impact of Permanently Closing Left Turn Movements from Abbott Street</u> Onto Highway 97 (5400-20)
 - Director of Works & Utilities, report dated October 1, 2002
 - Director of Works & Utilities, supplemental report dated October 16, 2002

Staff:

- At the Regular Meeting of October 7, 2002, a staff recommendation to reinstate left turns from Abbott Street onto Okanagan Lake bridge and through traffic movements from Abbott Street to downtown upon completion of the Abbott Street Recreational Corridor was defeated by a tie vote of Council.
- Further consideration of the matter was deferred to this meeting to allow Council additional time to consider the impact of permanently removing left turning movements from Abbott onto the bridge.
- The supplemental report reiterates the advice provided verbally by staff when this matter was discussed two weeks ago.
- If Council wishes to eliminate left turns from Abbott onto the bridge, the RCMP have advised that signage instead of an island to direct traffic would be difficult to enforce.

Council:

- Staff to work toward solving the problems that would allow the elimination of left turns from Abbott to the Highway in future. That could include dual left turning lanes off Richter and Pandosy onto the Highway; relocating the traffic signal from Pandosy and the Highway to Water Street and the Highway; implementing traffic calming measures on the side streets between Pandosy and Abbott (i.e. Lake and Park Avenues) to reduce the speed of commuters wanting to get to Abbott Street.

Staff:

- The long term solution would be the one-way couplet.
- Can proceed with the necessary analysis and report back with options to handle the traffic projections for the next 5 years.
- Phase 2 of the Abbott Street Recreational Corridor is targeted for completion by late June/early July 2003.

10. COUNCILLOR ITEMS

(a) Sharing of Correspondence Received by Members of Council From the Public

Councillor Shepherd noted that she and other members of Council received numerous emails and faxed letters with respect to the report under agenda item No. 4.1 regarding left turns from Abbott onto the Highway. She further noted that one of the faxed letters ended up being circulated by staff as a late item, thus singling it out for special attention. Councillor Shepherd suggested that a policy is needed for how to deal with the correspondence that is emailed and faxed directly to members of Council.

(b) Traffic Bylaw No. 8120

Councillor Cannan noted that last week the owner of a vehicle parked in the City Hall parking lot returned to the lot only to find that his vehicle was hooked up and ready to be towed. The tow truck operator charged him \$60 to drop the vehicle rather than towing it. Under Traffic Bylaw 8120 the fee would have been \$35 plus the storage fee had the vehicle been towed. Councillor Cannan asked that staff provide a report back with a recommendation for an amendment to include a drop fee in the Traffic Bylaw.

(c) Impact of Library Budget Increase on City of Kelowna Taxpayers

Councillor Day reported that City Finance staff have clarified for him that the impact of the 2003 increase of 3.99% in the library budget on the City budget would be less than 2% or less than \$1 for the average home owner in Kelowna.

(d) Changes to Contaminated Sites Legislation

Councillor Hobson reported that the Urban Development Institute (UDI) will be discussing changes to contaminated sites legislation at their November 30th UDI meeting and suggested City staff consider attending the meeting.
