- The downloading by senior levels of government to the municipalities in terms of transit, policing, and social programs has increased pressure on the City.
- General revenues are projected to increase by 3.7% over 2002 from \$8.6M to \$8.9M
- Departmental revenues are projected to increase by 4.3% over 2002 from \$15.1M to \$15.7M
- Net Departmental Operating budgets are projected to increase by \$2.5M over 2002
- Total 2003 Capital Program is \$35M of which \$14.4M will be funded from general taxation.
- Total tax demand for 2003 is \$61.8M an increase of \$2.8M over 2002, partially offset by the estimated new construction revenues of \$1.5M.
- The estimated net impact on the average residential property prior to Council review of the 2003 budget is 2.25% or \$27.81.
