6. PUBLIC MEETING TO RECEIVE INPUT ON LIQUOR LICENCE APPLICATION:

6.1 Planning & Development Services Department, dated January 8, 2003 re: Liquor Licensing Application No. LL02-0010 – M.S. Developments Inc. (Nicholas Sintichakis) – 1630 & 1654 Ellis Street and 466 & 484 Leon Avenue

Staff:

- Applicant seeks Council support for a Class "D" (Neighbourhood Public House) liquor licence for a new pub in the downtown area.
- Proposed occupancy load would be approximately 98 persons and hours of operation would be from 11 a.m. to 1 a.m.
- Application is being processed under the old liquor license category of a Class "D" license as it was in-stream with the LCLB at the time of implementation of the new classification system. If this application is approved, it will be converted to a liquor primary license but with all the same conditions (i.e. Occupant load and hours of operation) as would apply to a class "D" establishment.
- Applicant is also planning to construct a class "G" Licensee Retail Store (LRS) next to the pub on Leon Avenue. The LCLB has approved in principle the issuing of a Class "G" License to the applicants. City is not required to provide input on the Licensee Retail Store application but applicant may be required to come back for rezoning should they wish to pursue the LRS.
- RCMP do not support the application as it would add a burden to existing policing resources.

City Clerk advised the following correspondence had been received:

- Seven letters of support from Downtown Kelowna Association, Dr. Jeffrey A. Stewart, Keith Funk, Kenneth Sarrecki, Don Campbell, Don Huculak, and Paul Mitchell Reasons: upscale pub is needed in the area.

- Two petitions of support representing 11 people stating upscale pub is needed in area.
- Seven form letters of support stating the area would benefit from this establishment
- Two letters of opposition from John Hurd and Blake McFetridge stating lack of parking, consistent problems with drunks and drugs being disruptive as concerns.
- Late letter of opposition received from Ki-Low-Na Friendship Society.

Mayor Gray invited the applicant or anyone in the public gallery who deemed themselves affected to come forward or any comments from Council.

Bert Hicks, agent for applicant:

- Pub will cater to businesses and residents of that area of Kelowna.
- Will bring into the area a different type of person and upgrade the area.

Anne Patrone, 108-2900 Abbott Street:

In support of this application as it is something needed in the downtown area.

Harry Thompson, 753 Rowliffe Avenue – Christian Life Fellowship:

 Opposed to the application because of the location of the employment office across the street.

Assunta Rosal, Program Manager, Ki-Low-Na Friendship Society, 442 Leon Avenue:

- Opposed as this street is already overburdened with attempting to provide services to the disadvantaged and proposed pub will only complicate the issues.
- They have incurred increased training costs for their staff to deal with people who are intoxicated.

Council:

- Good support from businesses in the area for the application.
- Part of the problem of social issues in that area could be the number of social agencies located there.
- There have not been any complaints about the two pubs licenses already approved by Council.
- Requested that staff check with the Solicitor General as to whether or not they will recognize the City's zoning bylaw as it relates to the control of Liquor Retail Sales outlets.
