1. CALL TO ORDER

Deputy Mayor Clark called the meeting to order at 1:30 p.m.

2. Councillor Given was requested to check the minutes of the meeting.

3. PUBLIC IN ATTENDANCE

3.0 Veendam Sister City Association

Deputy Mayor Clark introduced Art Brown and Ron LeRoy, two veterans representing Kelowna at the upcoming Remembrance Day services in Veendam, and Summer Larose, the exchange student who will be attending school for a year in Veendam, and thanked the members of the Association for arranging these visits and exchanges.

3.1 Presentation by President Katy Bindon re: <u>Update of Okanagan</u> <u>University Campus Activities</u>

Katy Bindon, president, Okanagan University College:

- Brought Council up to date on OUC's curriculum development plan and initiatives.
- Responded to questions of Council.

4. UNFINISHED BUSINESS

4.1 Director of Human Relations, dated March 25, 2003 re: <u>Jail Guard Services Contract</u>

Mary-Lou Bailey, president of CUPE 338:

- Áddressed Council on behalf of the male and female fulltime and relief guards.
- Was before Council 2 years ago asking that the City consider the consequences of contracting out these jobs and the impact on the families of the incumbants.
- CUPE was provided with the cost information they requested and was able to identify about \$5,000 in cost savings but could not come close to what can be saved by contracting out the service to the Corps of Commissionnaires.
- Outlined the responsibilities of the jail guard position.

- Concerned that the people the Corps bring in may not be as dedicated to carrying out the guarding function to the same high level of service currently provided. Urged Council to direct the managers to work with the RCMP and monitor the level of turn over and to record any increase in RCMP presence in the cells as opposed to their being out on the street as a result of contracting out this service.
- City of Kelowna taxpayers should pick-up the tab when the Province downloads instead of dealing with the cuts through staff cuts and service reductions.
- Hope alternate job opportunities will be found for the relief employees within the City operation.

Staff:

- Two of the three full-time guards will go back to positions they had before; openings are available so no bumping rights will have to be exercised.
- There are about 15 employees on the jail guard relief roster.

Inspector Bill McKinnon, Kelowna RCMP Detachment:

- Fingerprinting and other functions the guards are now doing are actually not part of their required duties but rather are the responsibility of the Member that made the arrest and brought in the prisoner.
- Is satisfied that the Corps of Commissionaires will be able to provide qualified people to do the job as required.

Council:

- Staff to monitor the turn-over of staff and its impact on training and having qualified people on the job and report back to Councl before the end of the term of the contract.

5. PLANNING

5.1 Planning & Development Services Department, April 2, 2003 re: <u>City of Kelowna Neighbourhood Satisfaction Survey</u>

Staff:

- Opposition to inflill development has a significant impact on housing affordability and choice. The purpose of the survey was to investigate the quality of life impacts from infill forms of housing in established neighbourhoods.
- Canada Mortgage and Housing provided the funding for the study.
- Close to 50% of the 2,000 surveys that were sent out were returned.
- Highlighted the major findings of the study noting on-street parking, increased traffic volumes were the concerns raised.
- The information will be used to provide another level of analysis in planning initiatives.

April 7, 2003

Council:

- Consider distributing the survey results to the real estate board as the information could be helpful for people moving to or wishing to relocate in Kelowna.
