BYLAW NO. 9005

Officer Positions Establishment Bylaw

WHEREAS the Local Government Act empowers Council, by bylaw, to establish officer positions and to assign the powers, duties and functions to those officer positions;

NOW THEREFORE the Municipal Council of the City of Kelowna in open meeting enacts as follows:

CITATION

This bylaw shall be cited for all purposes as "City of Kelowna Officer Positions 1. Establishment Bylaw No. 9005".

OFFICER POSITIONS

- 2. The following positions are hereby established as officer positions of the City of Kelowna:
 - (a) City Manager;
 - Director of Financial Services; and
 - (b) (c) City Clerk.

POWERS, DUTIES AND RESPONSIBILITIES

- 3. In addition to any other powers, duties and functions assigned by Council, or required or permitted by the Local Government Act or any other enactment, the City Manager shall be responsible for the chief administrative functions of the City of Kelowna as outlined in Section 197 of the Local Government Act.
- 4. In addition to any other powers, duties and functions assigned by Council, or required or permitted by the Local Government Act or any other enactment, the Director of Financial Services shall be responsible for the financial administration functions of the City of Kelowna as outlined in Section 199 of the Local Government Act.
- In addition to any other powers, duties and functions assigned by Council, or required or permitted by the *Local Government Act* or any other enactment, the City Clerk shall be 5. responsible for the corporate administration functions of the City of Kelowna as outlined in Section 198 of the Local Government Act.

ENACTMENTS

6. Any enactment referred to herein is a reference to an enactment of British Columbia and regulations thereto, as amended, revised, consolidated or replaced from time to time.

HEADINGS

7. The headings given to Parts, Sections and Paragraphs in this bylaw are for convenience of reference only. They do not form part of this bylaw and will not be used in the interpretation of this bylaw.

OATH OF OFFICE

8. The oath of office as set out in Schedule "A" to this Bylaw is hereby adopted as the oath of office for the officer positions of the City of Kelowna.

REPEAL

9. "City of Kelowna Officer Positions Establishment Bylaw No. 8447" is hereby repealed.

EFFECTIVE DATE

10. This bylaw shall come into full force and take effect on the 28th day of April, 2003.
