1.0 RECOMMENDATION

THAT Council not support a licensed person capacity increase proposed by Gotchas Nightclub for 238 Leon Avenue.

2.0 SUMMARY

The applicant is seeking Council support for a Licensed Capacity Increase. The applicant is proposing to expand the floor area of the establishment for a proposed sports room.

3.0 BACKGROUND

3.1 The Proposal

In December of 2002 the Provincial government's Liquor Control and Licensing Branch made significant changes to Liquor Licensing regulations in British Columbia. One of the results being that local governments now have input on capacity increases only in cases where the physical size of a liquor primary licensed establishment is proposed to change.

The applicant is proposing to increase the physical size of the cabaret by creating a new "sports room" on the second floor of the establishment. The space is currently being used as a storage area. The existing person capacity of the establishment is 313. The proposed increase in floor area would allow a person capacity of 405, an increase of 92 persons. The expansion is not increasing the floor area of the existing building and therefore there are no additional parking requirements.

3.2 Site Context

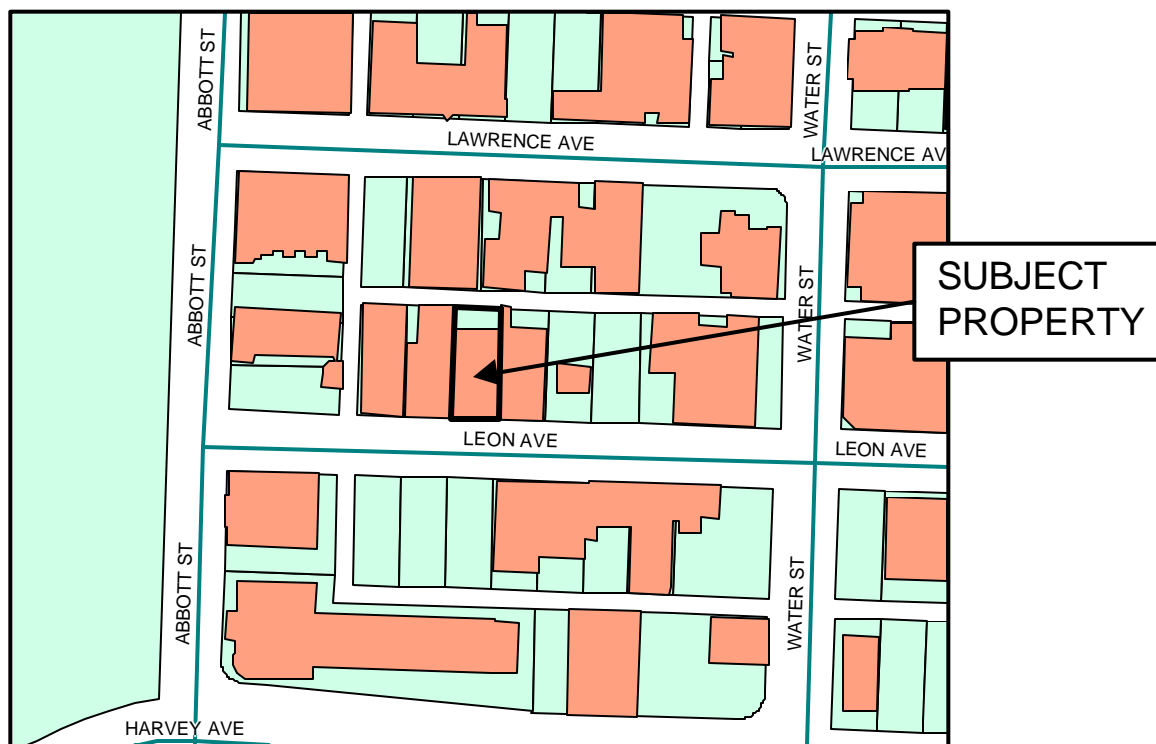
The subject property is located on the north side of Leon Avenue between Water and Abbott Streets, in the Central City Sector.

Adjacent zones and uses are:

North -C7 –Central Business Commercial – The Finer Choice Restaurant
East -C7 –Central Business Commercial – Yawbus 3 Sub and Pizza
South -C7 –Central Business Commercial – Parking Lot
West -C7 –Central Business Commercial – La Bussola/Junior's/Club Oasis

4.0 TECHNICAL COMMENTS

The application has been submitted to various technical agencies and City departments, and the following comments have been submitted:

4.1. Inspection Services Department

- a) Occupant load is limited to 92 in this new area
- b) Washrooms ok.
- c) Exits ok.
- d) There are some Building Code issues to be dealt with at the building permit stage.

4.2. RCMP

The RCMP is represented on the Mayors task force and will not support any new applications or extensions until the task force is completed.

4.3. Fire Department

Fire alarm to be extended into new addition and zoned accordingly.

4.4. Public Health Inspector

Ensure smoking compliance with Environmental Tobacco Smoke Reg. 03/200.

5.0 PLANNING AND DEVELOPMENT SERVICES DEPARTMENT

The Planning and Development Services Department is concerned with the proposal. There is apprehension that this person capacity increase will only exasperate existing problems in this area that occur when the nightclubs close in the early morning.

6.0 ALTERNATE RECOMMENDATION

THAT Council support the person capacity increase (from 313 to 405 persons) proposed by Gotcha Nightclub for 238 Leon Avenue;

AND THAT Council direct staff to forward the appropriate resolution to the Liquor Control and Licensing Board in Victoria.
