## 6. PUBLIC MEETING TO RECEIVE INPUT ON LIQUOR LICENCE APPLICATION:

6.1 Planning & Development Services Department, dated April 9, 2003 re: Liquor Licensing Application No. LL03-0006 – Gotcha Nightclub – 238 Leon Avenue

The City Clerk advised that the following application was advertised to this agenda prior to Council's consideration of the interim report of the Mayor's Entertainment District Task Force on May 5, 2003 when a portion of the resolution that Council adopted stated that the hours of liquor service for Liquor Primary establishments within the City of Kelowna would remain at 2:00 a.m. at this time. The applicant has asked that this application for extended hours be considered by Council regardless.

## Staff:

- The application is to extend the hours of operation for Gotcha Nightclub which is classified as a Liquor Primary (LP) licence from 2 a.m. to 4 a.m., 7 days a week.
- The applicant probably would not stay open that late every day of the week but the changes in liquor licensing regulations allows that and so that is what is being requested.
- Staff recommend that Council not approve the extended closing time.
- If Council denies the application, the same application could not be made for a period of 6 months.

The City Clerk advised that the following correspondence had been received:

- letter from Richard Sharpe, 505-1585 Abbott Street, opposed on the basis that the application is inconsistent with the Downtown Plan and the objective to achieve a healthy mix of residential and business development in the downtown area.

Deputy Mayor Clark invited anyone in the public gallery who deemed themselves affected by this liquor licence application to come forward.

#### David Habib, 4493 Stewart Road East:

- Four cities have already been approved for and are running on the extended hours. Penticton feels their request for extended hours will be approved by the Liquor Control Board within the next few weeks. Under the new hours, the clubs would have to close the doors at 2:30 a.m. and not allow anyone in after that time, liquor service would continue until 4 a.m. and the premises would be closed at 4:30 a.m.

- If the nightclubs in neighbouring communities can stay open until 4 a.m. then the clubs in Kelowna need the same hours for an even playing field.

Suggest that Council approve the extension of hours for a 2 or 4 month trial period. The Liquor Control Board have indicated that a test period can be easily done within a couple of weeks and they strongly support that.

- Vancouver tried extending the clearing out period by 30 minutes (sale of alcohol ended at 2 a.m. but patrons could stay until 3 a.m. before leaving) and experienced a 30% reduction in the occurrence of incidents in the evenings.
- Supports the extension of hours for Gotchas Nightclub.

#### Staff:

- The interim report was provided by the Task Force to give Council direction on dealing with applications for extended hours.
- The Task Force has asked for and received input from the public and will now formulate recommendations that will specifically go to the industry and lead up to the recommendations in the final report to Council.

Andrew Mercer, Manager of Splashes Nightclub:

- Read an excerpt of an article in a local newspaper saying downtown clubs will have to close earlier than other clubs in the City of Kelowna and neighbouring communities to force or coerce them into leaving the downtown.
- Whatever rules Council comes up with have to apply to all the clubs equally across the board.

Doug McMinniman, Manager of Gotchas and Club Oasis:

- Is opposed to allowing increased capacity and extended hours for clubs outside the downtown core giving them an unfair business advantage.
- Wants the same rights as the other club owners.
- It used to be that people were lined up at 9 p.m. to get into the clubs but times have changed and now people do not start coming until 11 p.m. to midnight. That does not give much time for the clubs to generate enough revenue to cover expenses.
  Willing to compromise and go for a 3 a.m. end to liquor service with a 1 hour clearing
- Willing to compromise and go for a 3 a.m. end to liquor service with a 1 hour clearing out period and 4 a.m. closing.

## Council:

- Staff to readvertise that public input will be accepted when the in-stream liquor licensing applications from Gotchas, Flashbacks, etc. are rescheduled to a Council meeting concurrent with the final report of the Mayor's Entertainment District Task Force.

- Will be planting 6 ft. cedars on both sides of the property to help with the privacy issue.
