3.1 Presentation by Lise Cloutier and Robyn Clarkson, Outreach Workers, Kelowna Drop-In & Information Centre re: Kelowna Homelessness Networking Group

Lise Cloutier and Robyn Clarkson, Outreach Workers:

- The Kelowna Homelessness Networking Group was formed in June 2002 and is comprised of representatives from over 50 different community agencies.
- Presented the results of their first census which was conducted on the night of March 12, 2003 out of the Kelowna Drop-In and Information Centre.
- The goal is to conduct a census bi-annually. The next census is scheduled for November 2003 and the intent would be to report those results to Council in early 2004.
