BYLAW NO. 9092

Road Exchange Bylaw

A bylaw pursuant to Section 525 of the *Local Government Act* to authorize the City to dispose of a portion of highway, being a portion of the North End Connector in exchange for a portion of Lot 1, Plan 19104 in the City of Kelowna, British Columbia

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. The City of Kelowna is hereby authorized to convey to the registered owners of Lot1, Plan 19104, that portion of highway comprising shown hatched in bold black as Closed Road Parcel 2 lying adjacent to Lot 1, Plan 19194 comprising 98 m², on Reference Plan prepared by N.R. Denby, B.C.L.S., and completed on October 22, 2003 attached to this Bylaw, for the sum of One Dollar (\$1.00) and other valuable consideration and in exchange for that portion or tract of land described in Paragraph 3 following.
2. The said Closed Road described in the foregoing Paragraph 1 is hereby stopped up and closed to traffic.
3. The lands described in Paragraph 1 are conveyed from the Crown Provincial in exchange for the transfer from the registered owners of that portion of Lot 1, Plan 19104 comprising an area of 127 m² shown in bold black as Parcel 1 on the Reference Plan referred to in Paragraph 1 above.
4. The said road/lane described in the foregoing Paragraph 3 shall be established as a portion of highway.
5. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.
6. Before adoption of this bylaw, public notice of intention shall be given by advertisement pursuant to Section 525 of the *Local Government Act*.

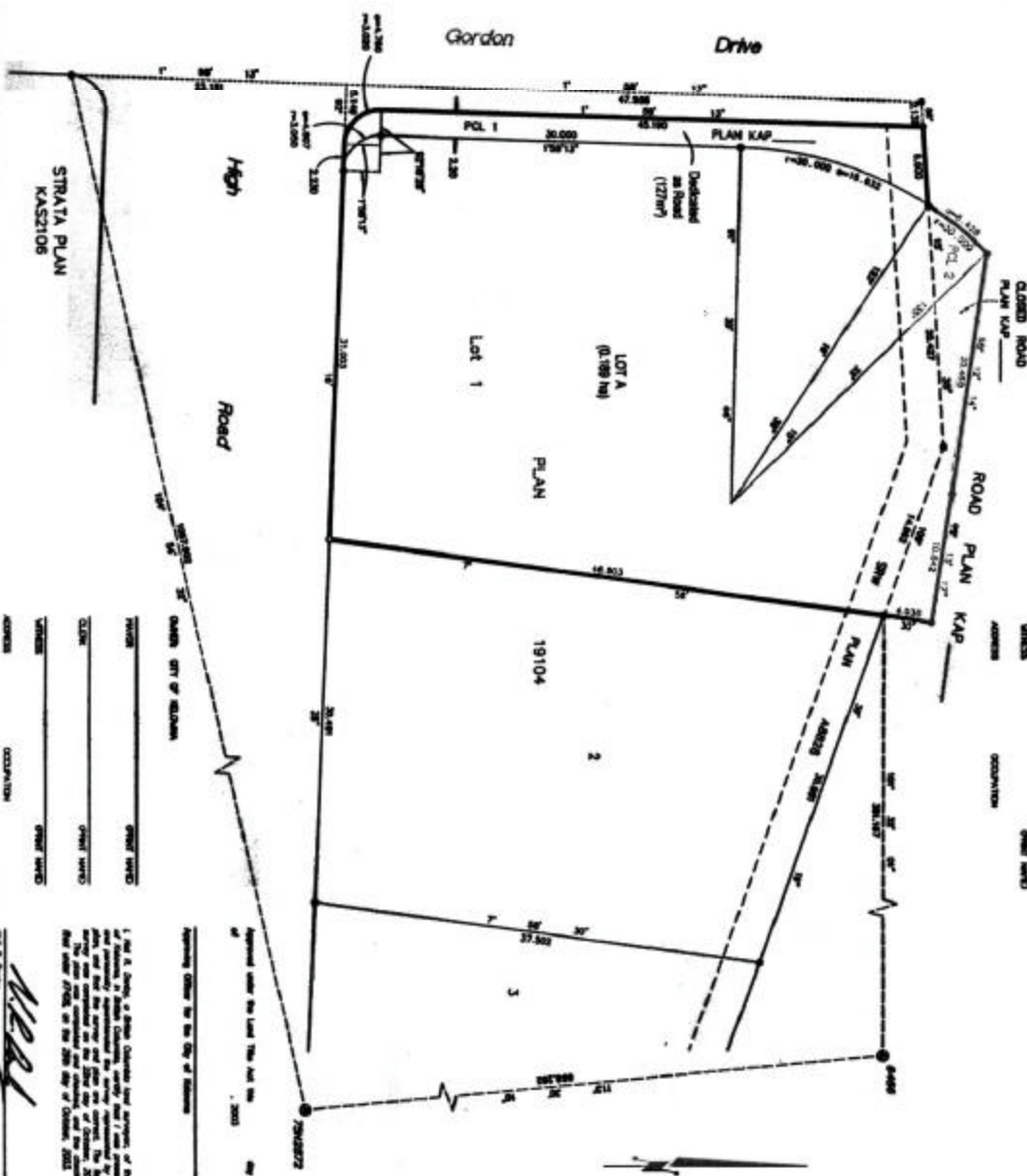
