- 10. COUNCILLOR ITEMS
- (a) Christmas Decorations for Town of Barrier

Councillor Shepherd commented that the Town of Barrier is looking for old Christmas decorations for their community. Referred to the Parks Manager to see if we have any decorations we could spare.

## (b) Roads in South Mission

Councillor Shepherd commented that temporary road closures on Frost Road, and South Ridge Road not being paved, are frustrating the area residents and would be of concern should the residents ever need to exit the area in a hurry. She asked that staff provide Council with an update on the timing for road improvements in South Mission area.

The City Manager reported that a second access road to Southridge Drive is under construction now and will likely be completed by next Spring. Access through the quarry will be available sometime in 2004 depending on the rate of development.

## (c) <u>Proposed New Provincial Legislation - Bill 75</u>

Councillor Cannan referred to a bulletin put out by the Union of British Columbia Municipalities about proposed Bill 75 – Significant Projects Streamlining Act. The Bill usurps the power from local government as it would allow any Minister authorized by Cabinet to replace any local government bylaw, plan, regulation, policy, etc. to facilitate the approval or development of a provincially significant project.

## (d) Mission District Park Sports & Recreation Complex

Councillor Hobson commented that construction work on the Mission District Park Sport & Recreation Complex is apparently behind schedule and asked for a report from staff on the status of the project.

Councillor Blanleil reported that the ice surfaces are all built but the preload area for the indoor fields is still sinking. It could be that the ice surfaces get opened for use in advance of the rest of the facility.

## (e) Crawford/Stewart Road Truck Route

Councillor Hobson asked for a report from staff on what has been done, to date, toward implementation of the plan for handling truck traffic Crawford Road and Stewart Road West.

# (f) <u>Casorso Bridge</u>

Councillor Blanleil asked that staff have a look at the Casorso Bridge because the antislip surface on top of the wood and the lines are gone.

## (g) Fire Recovery

The City Manager commented that many Kelowna businesses are generously offering discounts to people who suffered losses from the Okanagan Mountain Provincial Park forest fire. In order that the businesses can know when an individual qualifies for this discount, an official letter is being sent out from the City Manager's office to all individuals who have registered losses at the Recovery Centre. The letters can be presented to local businesses as proof of loss.
