3.4 Planning & Corporate Services Department, dated November 26, 2003 re: Official Community Plan Amendment No. OCP03-0013 – Amendment of Bylaw No. 7600 (Amendment Bylaw No. 9096)

### Staff:

- It would be difficult to consider the DCC bylaw apart from the Transportation network because the DCC bylaw is largely driven by the Transportation network.
- There are a number of multi-family projects that are on hold pending what is anticipated in the development community to be a January/February resolution of the DCCs through the OCP.

#### Council:

- The Regional Transportation Committee, First Nations and the Ministry of Transportation are having a workshop regarding the Okanagan Lake bridge project. The outcome of that meeting could impact Council's decisions regarding the one way couplet portion of the Transportation network in the OCP.
- The couplet proposal has been provided for in the OCP for years. The proposed amendment to the OCP would make relatively minor changes to that couplet proposal. No final action would be taken re the couplet until the public has the information Council has regarding the alternatives and the costs of those alternatives.
- It was improper that the Crown Provincial provided \$20 million to solve bridge access problems on the west side of the lake but nothing to help solve those problems on the east side of the lake.
- Discussed deferring the date of the public hearing for this OCP amendment to after the Regional Transportation Committee's meeting and after the public has been presented with the one-way couplet proposal and the alternative options that have been considered by Council. Agreed to proceed with the January 15<sup>th</sup> target date for the Public Hearing.
