A Regular Meeting of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Monday, February 2, 2004.

1. <u>CALL TO ORDER</u>

Mayor Gray called the meeting to order at 1:37 p.m.

2. Councillor Shepherd was requested to check the minutes of the meeting.

3. <u>PLANNING</u>

3.1 Planning & Corporate Services Department, dated January 27, 2004 re: <u>Rezoning Application No. Z03-0060 and HAP03-0017 – Sylvia Wearne</u> and Gerald Sager (Sylvia Wearne) – 255 Lake Avenue

Staff:

- The property is within the Abbott Street Heritage Conservation Area and therefore a Heritage Alteration Permit is required for proposed changes to the building.
- The proposed addition would include a single vehicle garage, a secondary suite, and additional living space for the principal dwelling. Variances are being requested for the side and rear yard setbacks through the Heritage Alternation Permit which would be considered by Council concurrent with adoption of the zone amending bylaw.

 The Community Heritage Commission reviewed the application and passed a recommendation of support with suggestions for changes to the design.
- The Advisory Planning Commission reviewed the application and passed a recommendation of support for the rezoning but did not support the Heritage Alteration Permit because of the proposed encroachment into the rear year setback.

5.5 Transportation Manager, dated January 26, 2004 re: <u>Regulation of</u> <u>Speed and the Operation of Trucks on McCulloch Road Through KLO</u> Creek Canyon (BL9167; 4520-20; 5420-20)

Staff:

The intent is to reduce the speed limit on McCulloch Road through the Canyon to maximum 30 km/hour, and to require operators of vehicles with more than three axles to obtain a "Reduced Speed Road Permit" from the City in order to use roads such as this. The permit would enable the City to require the operator of the vehicle to provide a flag person to stop oncoming traffic when a truck is passing through the designated section of road.

- 8. <u>COUNCILLOR ITEMS</u>
- (a) <u>Residents' Associations Access to City Documents</u>

Councillor Shepherd expressed concern that residents' associations are required to pay to obtain a copy of documents such as the City of Kelowna Official Community Plan, Transportation Plan, etc.

Staff advised that the most up to date versions of the documents are available on the internet, and copies of City-produced documents are also available at the public library. Staff will be bringing forward a Fees and Charges Bylaw that could include a section authorizing that copies of certain documents could be made available to a Residents' Association on request, at no cost.

(b) Kelowna Women's Centre

Councillor Shepherd put Council on notice that she will be bringing forward a notice of motion for Council to pass a resolution that calls on the Provincial Government to continue core funding to run the Kelowna Women's Centre.

(c) Okanagan Lake Bridge

Councillor Shepherd commented that there appears to be a lot of inaccurate information in the community with regard to the bridge issue. The Ministry of Transportation has done a recent traffic survey and an audit of the condition of the bridge but has not shared the results of either with Council or the public, nor has MOT shared its studies and management plans over the next 5 to 20 years. Without this information it is difficult to ensure that the best decision is made with respect to the existing bridge and to properly evaluate whether a second crossing is needed. Councillor Shepherd suggested that the City lead a public forum on the bridge issue.

Council agreed that a letter could be sent to the Ministry of Transportation suggesting that MOT consider holding a public forum and asking for copies of the results of their studies and plans for the existing bridge and for a timing commitment for the second lake crossing.

(d) Parking in the Downtown

Councillor Cannan commented that some businesses on Bernard Avenue need their clients to be able to park for longer than 1 hour and suggested that Council's representative on the Downtown Kelowna Association ask the DKA to see if its members would consider opening up a portion of the downtown for 2 hour parking.

(e) Extension of Sanitary Sewer to Rutland

Councillor Horning noted that there are still pockets of Rutland that are not yet serviced with sanitary sewer and suggested that the City of Kelowna initiate a specified area to extend sanitary sewer to those areas. Referred to staff who are already working on this issue.

(f) <u>Parking Problems – Lakeshore Road</u>

Councillor Blanleil recalled that City Planning Department staff were going to meet with representatives of Manteo and Eldorado Hotels and other interested parties to discuss how to resolve existing parking problems and meet future parking needs in that area. He expressed concern that the meeting has not yet taken place and the summer season is fast approaching. Staff to investigate.
