#### 4.5 Planning & Corporate Services Department, dated February 10, 2004 re: <u>Heritage Revitalization Agreement No. HRA03-0002 – Robert & Benigna</u> <u>Cummings – 2034 Pandosy Street</u>

Staff:

- The applicants intend to refurbish the Shepherd heritage dwelling and extend a driveway down the side of the property to access 2 parking stalls and the garage in the proposed new 1-storey building. The two dwellings would be separated by a hedge and a fence.
