RECOMMENDATION:

THAT the Tender for the 2004 Super Pave Trial be awarded to the low bidder Emil Anderson Construction Ltd. in the amount of Six Hundred & Thirty-one Thousand, Two Hundred & Ninetysix dollars & Fifty-eight cents (\$631,296.58) including GST.

BACKGROUND

In response to the City's invitation to tender for these projects, three (3) bid packages were picked up as shown below:

1.	Emil Anderson Construction Ltd., Kelowna	\$ 631,296.58
2.	Peter's Bros. Construction Ltd., Penticton/Kelowna	\$ 659,630.39
3.	Westlake Paving & Aggregates Ltd., Kelowna	\$ 670,839.76

All prices are lump sum and included 7% GST and no contingency. The City Works & Utilities Department has reviewed the bid submissions, checked for their arithmetic accuracy and where applicable, checked references.

Emil Anderson Construction Ltd., Peter's Bros. Construction Ltd. and Westlake Paving & Aggregates Ltd. all complied with the tender specifications and drawings, including the specified bid bond.

This Project is a joint venture with Ministry of Transportation (MoT) and the City of Kelowna. This is a special asphalt mix design being shared approx. 50% for each party.

Emil Anderson Construction Ltd. tender for the 2004 Super Pave Trial is within the total budget for this work. Funding for this project is available from Account No. 3301. See attached sheet for list of projects.
