8. <u>COUNCILLOR ITEMS</u>

(a) School Crossing – Lakeshore Road at Anne McClymont School

Councillor Shepherd reported that she has received complaints about the safety of children crossing Lakeshore Road to get to Anne McClymont School, particularly in the mornings between 8:00 a.m. and 8:35 a.m. when traffic is very heavy, and about the long line of traffic that backs up in both directions during these times. She asked that staff work with the school to see what can be done to improve the situation. Referred to City Manager.

(b) Recognition of Original Owner of Parkinson Recreation Centre Site

Councillor Clark referred to an email that members of Council received from the grandchildren of Mike and Jenny Johnson who started Willowbrook Farms on the Parkinson Recreation Centre (PRC) site and who planted the Willow trees along the creek on the PRC site. Councillor Clark asked that staff consider some of recognition of this pioneer family. Referred to City Manager.

(c) Safe Streets Coalition

Councillor Given commented that the Safe Streets Coalition has come up with a Safe Streets Initiative across British Columbia in pursuit of legislation to assist the police in dealing with individuals displaying unwanted and aggressive behaviour. To this end, Vancouver-Burrard MLA Lorne Mayencourt is expected to introduce a private members bill within the next few weeks to introduce a Safe Streets Act and Urban Trespass Act.

R378/04/04/19 THAT the provincial government enact a "Safe Streets Act" similar to the legislation already in existence in Ontario to allow police and communities to more effectively deal with aggressive behaviour and to ensure that the penalties and laws are consistent throughout the province;

AND THAT Mayor Gray send a letter on behalf of Council to Premier Gordon Campbell with copies to the Solicitor General and our local MLAs requesting support for such legislation;

AND FURTHER THAT a late resolution to this effect be prepared for presentation at the 2004 Okanagan Mainline Municipal Association convention.

(d) <u>Homesite Severances</u>

Councillor Horning asked that staff review the process for extensions to Preliminary Layout Review letters for homesite severances, noting that the approval of the Land Reserve Commission is ongoing, but the City approval is only good for 180 days and after that a \$100 fee is charged for each extension. Referred to City Manager.

(e) Lift Times for Span – Okanagan Lake Bridge

Mayor Gray reported that instead of asking that the Coast Guard eliminate the 2:00 p.m. lift time for the bridge span, efforts are now being directed toward moving that lift time to 1:00 p.m. The Yacht Club and the Regional Transit Manager have both indicated support for taking that approach as it is anticipated that changing the time will have a better chance of success than eliminating a lift time.
