3. REPORTS

3.1 Director of Works & Utilities, verbal report re: <u>Traffic Signals – Lakeshore/Creighton</u>

Staff:

- The new signal was installed 2 years ago, because of the City's obligation from years previous to provide a controlled agricultural crossing at Lakeshore/Creighton.
- The signal flashes yellow until it is activated by a push button to turn green.
- The intersection is becoming increasing unsafe because motorists have become accustomed to the continually flashing yellow light and, it would seem, not seeing it any more so when the light turns red motorists are not prepared and barely get stopped in time.
- Unless directed otherwise, the intent is to change the signal so that the light would be solid green all the time, until activated by a vehicle to change to red.

Council:

- Agreed with the proposed change. Directed staff to issue a news release regarding the change and include in it, an explanation of why the light was installed at that intersection.
- Staff to consider replacing the 4-way stop at the bottom of Summit Drive with a traffic signal.
